to make," he said. "But, I realize I'll have my fun for a week, taking photos with it and getting the ownership photocopied."

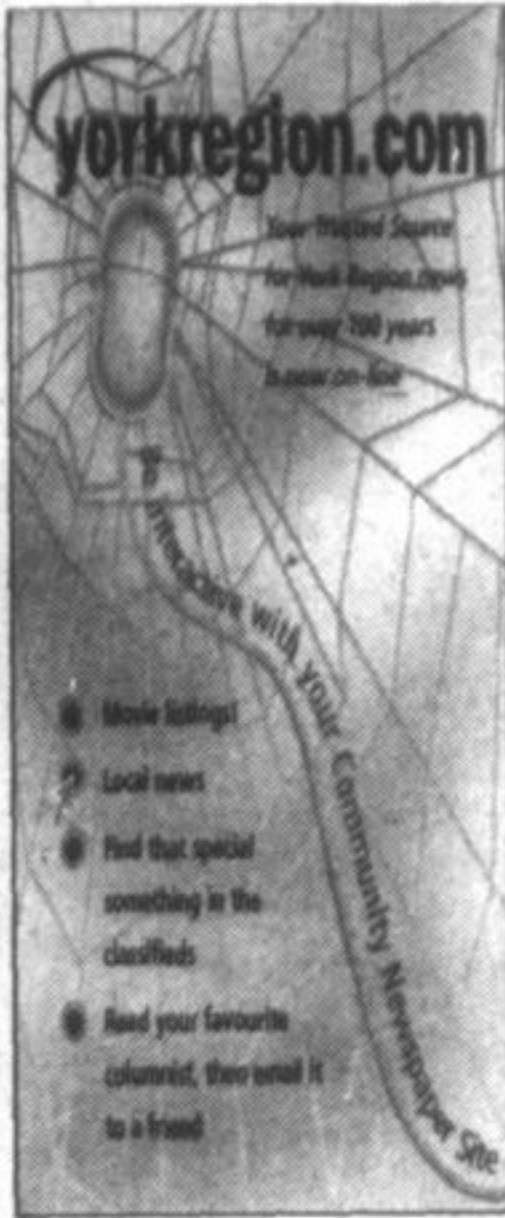

NOTICE OF THE PASSING OF TWO ZONING BY-LAWS

TAKE NOTICE that the Council of The Corporation of the Town of Whitchurch-Stouffville passed By-law 2008-145-ZO and By-law 2008-146-ZO on the 4th day of November, 2008 under Section 34 of the Planning Act, 1990.

AND TAKE NOTICE that any person or agency may appeal to the Ontario Municipal Board in respect of the by-laws by filing with the Director of Planning & Building Services of The Corporation of the Town of Whitchurch-Stouffville not later than the 5th day of December, 2008 a notice of appeal setting out the objection to the by-laws and the reasons in support of the objection. In accordance with Section 34(19) of the Planning Act the notice of appeal must be accompanied by the Ontario Municipal Board Act prescribed fee of \$125.00, payable to the Minister of Finance.

In addition to the fees listed above, pursuant to By-law 2008-010-FI, a processing fee of \$170.00 per Ontario Municipal Board appeal, payable to the Town of Whitchurch-Stouffville, is required to be paid at the time of filing a Notice of Appeal.

The land to which the Zoning By-Law Amendments apply are the subject of Plan of Subdivisions 19T(W)-98006 and File No. 19T-99001.

An explanation of the purpose and effect of the by-laws, describing the lands to which the by-laws apply, and a key map showing the location of the lands to which the by-laws apply are below. The complete by-laws are available for inspection in my office during regular office hours.

NOTE: Only individuals, corporations and public bodies may appeal a zoning by-law to the Ontario Municipal Board. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group.

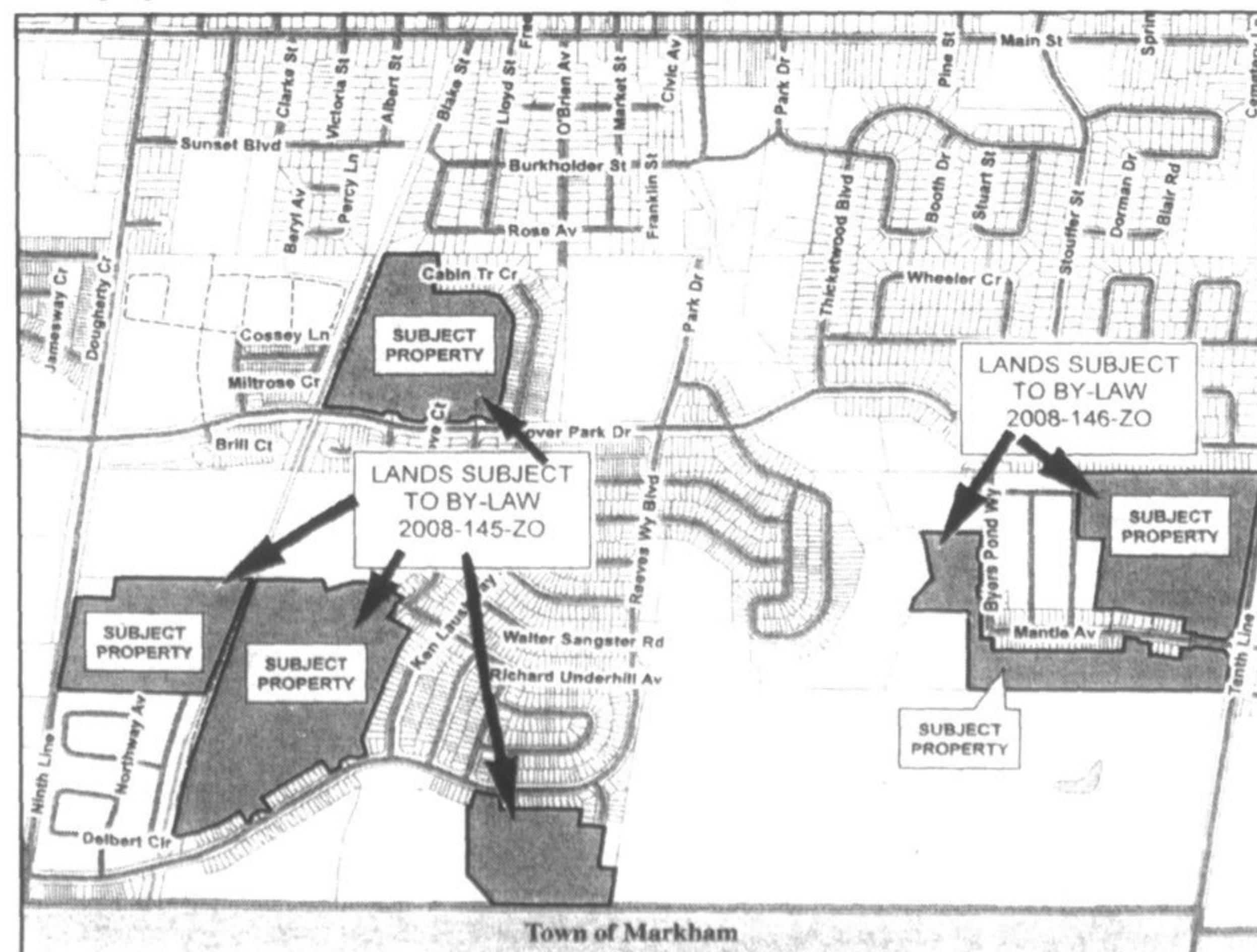
No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the Ontario Municipal Board, there are reasonable grounds to add the person or public body as a party.

EXPLANATORY NOTE BY-LAW NUMBERS 2008-145-ZO & 2008-146-ZO

The two By-laws affect certain lands within the Lebovic Enterprises Ltd. plan of subdivision [File No. 19T(W)-98006] and 1320991 Ontario Ltd. plan of subdivision [File No. 19T-99001]. The subdivision lands are located in Part of Lots 32, 33 & 34, Concession 9 (M), within the southeast quadrant of the Community of Stouffville. The attached location map conceptually identifies the location of the lands subject to the Amendments.

The two By-laws have the effect of undertaking the following:

- Add a new regulation to the residential zone classifications that will allow for a 7.0 metre (22.9 ft.) rear yard setback on all lots with less than 30 metres (98.4 ft.) of lot depth;
- Revise the zone regulation for an exterior side yard (corner lot property with two road frontages) to permit a 3.0 metre (9.84 ft.) setback for semi-detached units;
- Revise various residential zone classifications on Lots/Blocks within the Draft Approved plans of subdivision to implement the proposed red-line revisions to the subdivision layout.
