## **COUNCIL HIGHLIGHTS** DECEMBER 2, 2008

#### **ECONOMIC DEVELOPMENT STRATEGY**

Council approved the Economic Development Strategic Plan, 2009-2013 that will form the foundation of the Town's future Economic Development Program.

The Strategic Plan identifies four investment target areas in which the Town has developed a competitive advantage: 1. Emerging knowledge based businesses such as professional firms, architecture, engineering etc., 2. Large knowledge based businesses such as software development and advanced manufacturing, 3. Agriculture and environmental industries, and 4. Not-for profit sector.

#### 10% DISCOUNT ON TAXI FARES THIS FESTIVE SEASON

From December 3, 2008 to January 4, 2009 town-plated taxis will provide a 10% discount to riders to encourage drivers to make a responsible decision about drinking and driving during the festive season. Council approved temporary changes to the Taxi Licensing By-law to allow for the discount on metered taxi fares.

#### MAIN.STREET STATUS REPORT

strategic transportation project for the Town that will result in improvements to safety and traffic congestion as well as visual enhancements for the Western Approach and Gateway area. Phase I (Ringwood Drive to Winona Drive) is expected to be substantially completed by the end of 2008. Phase II (Highway 48 to Ringwood Drive) is planned for 2009 with Phase III (Winona Drive to Ninth Line) to follow in future years.

While many challenges have been encountered, Town staff, its Consultants, and the Contractor have responded with success in delivering the project in a timely manner. The remaining items in Phase 1 to be completed in 2009 include: landscaping and plantings, top lift asphalt, decorative treatments at intersections and completion of street lighting and traffic signals. The budget for the balance of work together with subsequent phases and related projects has also been reviewed and are included in the 2009 Capital Budget.

# CROSSING GUARD APPROVED FOR MILLARD STREET

Council approved a crossing guard, road markings and the appropriate signage for safer crossing of Millard Street, at the intersection with Glad Park Avenue, for children walking to either St. Mark Catholic School or Glad Park Public School. A study will also be conducted to review the option of an all way stop for the intersection.

#### **OVERNIGHT PARKING**

During the months of December through March, no parking is permitted on Town roads between 2:00 a.m. and 6:00 a.m. to allow for snow removal. Vehicles parked on roads during this time will be issued a parking infraction notice and fined \$50.00.

#### CHRISTMAS TREE SAFETY TIPS

#### Setting up your Christmas Tree:

- Before setting up the tree, saw two inches (5cm) diagonally off the butt.
- Use a tree stand that has widespread legs for better balance and a large water reservoir in which to immerse the tree butt.
- Trees are thirsty. They may drink up to four litres of water per day, be sure to check daily and supply fresh water as needed.
- If you allow the water level to drop below the bottom of the tree, a seal will form just as it does on a cut flower and a new cut will be necessary.
- Do not set your tree up near a heat source such as a radiator, television, fireplace, or heating duct.
- It should not block doors or windows.

#### Decorating your Christmas Tree:

- Use Canadian Standards Association (CSA) certified lights.
- Inspect lights before use. Check for cracked bulbs and for frayed, broken or exposed wires, and discard if faulty.
- Choose decorations that are flame-retardant, non-combustible and non-conductive.
- · Avoid using angel hair (glass wool) together with spray-on snowflakes. This combination is highly combustible.
- Turn off the tree lights when you leave and before you retire at night.
- NEVER USE LIGHTED CANDLES ON YOUR CHRISTMAS TREE AND ALWAYS KEEP LIGHTED CANDLES OUT OF REACH OF CHILDREN.

Remove the tree within 10 to 14 days. After that amount of time in a heated building, even the freshest tree can start to dry out.
