The purpose of the meeting is to advise Bloomington Area residents that the Region of York will no longer be providing Municipal water to service the existing residences or any new growth within the Community. The Municipal water program has been abandoned due to servicing policy conflicts associated with the implementation of the Oak Ridges Moraine Conservation Plan. The meeting will also identify results of a groundwater study that has been completed by a landowner who is advancing two plans of subdivision within the southeast quadrant of the community on the basis of full private services (ie: individual well and septic systems).
