A non-refundable tax credit of up to **\$750**.

**PENSION INCOME SPLITTING**

Split up to **50%** of eligible pension income with your spouse or common-law partner.

**HOME RENOVATION TAX CREDIT**

A non-refundable tax credit of up to **\$1,350**.

**TRADESPERSON'S TOOLS EXPENSES**

Deduct up to **\$500** from your net income.

**CHILDREN'S FITNESS TAX CREDIT**

A non-refundable tax credit of up to **\$75/child**.

**PUBLIC TRANSIT TAX CREDIT**

A non-refundable tax credit of **15%**.
