

SPORTS: Fun tournament remembers late officials

Pat Madigan event at Clipper complex this weekend

Pat Madigan served as a president of the Stouffville Amateur Hockey League and also found the time to do some officiating.

Since his untimely passing Feb. 8, 2008, the league still keeps the father of three close to its heart.

The league will honour their former cohort when they stage the third annual Paddy Madigan Charity Hockey Tournament Friday and Saturday at the new Stouffville Clippers Sports Complex.

Paul Dermody, SAHL president, noted

funds raised from the tournament will go to the family of J.P. Farrell, a former league referee who died last year in a boating mishap and the Stouffville Emergency Care Fund.

"After expenses, we hope to raise anywhere from \$5,000 to \$7,000," he said.

Most participants are from the SAHL.

"There might be one or two teams from outside Stouffville as they were good friends of Pat Madigan or J.P. Farrell," Dermody said.

The tournament will be a two-division format - an eight-team competitive men's

division of which each team must have a maximum of five players under 30 years of age and a nine- or 10-team co-ed recreational division in which each team must field at least three female players.

The men's division will not have any contact or slap shots.

"It's just fun shinny to raise money for the event," Dermody said.

The action begins at 5:30 p.m.
