## COUNCIL HIGHLIGHTS APRIL 21, 2010

### NEW FIRE CHIEF

Council approved the promotion of Robert McKenzie to the position of Fire Chief effective June 1, 2010. Fire Chief Chris Powers is retiring after more than 35 years in fire services within the province.

### DOWNTOWN FACE LIFT GRANT

Council directed the Downtown Stouffville Working Group (DSWG) to allocate funding for 2010 such that the first priority be the Building, Façade and Signage Grant program. The purpose of this program is to encourage improvements to the appearance and function of downtown buildings consistent with the municipality's vision. The loan would match the amount spent by the proponent up to a maximum of \$15,000 per property. The program would apply to a wide range of exterior and interior improvements.

### ADDITIONAL DOWNTOWN PARKING

Council approved the removal of the no parking restrictions pertaining to the former Fire Hall 51 at 6392 Main Street. To ensure that the fire trucks had unobstructed in and out access, no parking restrictions were in place. With the move of Fire Hall 51 to Weldon Road, there is no further need to maintain these no parking restrictions.
