#### **VETERANS PARKWAY**

Council approved the honourary road dedication of Mostar Street between Main Street and Hoover Park Drive as "Veterans Parkway" as requested by the Royal Canadian Legion Branch 459 to recognize and support the Veterans of Whitchurch-Stouffville.

PUBLIC NOTICE - As part of June 29, 2010 Council meeting, Council will consider the Town User Fees affected by the new Harmonized Sales Tax (HST) that became law in December 2009. Starting July 1, 2010, the Town of Whitchurch-Stouffville, like other municipalities across Ontario, will be collecting HST on behalf of the federal and provincial governments for certain programs and services offered by the Town. HST at 13% will be added to all applicable programs/ services that previously carried the GST.
