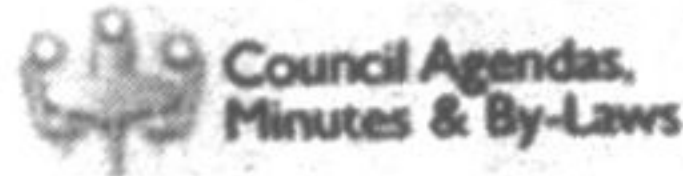

HST IS NO FINANCIAL BENEFIT TO THE TOWN

Council approved a revised General Fees and Charges by-law in light of the provincial Harmonized Sales Tax which must be added to appropriate Town services & programs, collected and remitted by the Town to senior governments. There is no financial benefit to the Town, in fact the introduction of the HST has redirected the allocation of staff time and resources to implement this change. In addition, the HST will add net costs to some of the Town's purchases, as municipalities will not be able to claim a full tax rebate.

BOOTH DRIVE EXTENDED

Council passed a by-law to change the name of the section of Park Drive between Burkholder Street and Thicketwood Boulevard to Booth Drive. There are no municipal addresses on this section of road.

FAILURE TO receive a tax bill does not eliminate the responsibility for payment of taxes nor the penalty charges for late payment.

For those ratepayers who have not yet received their supplementary tax bill for their new residence, please note that you may pay 'on account' to ease the tax burden before these bills are issued. These payments MUST be made at the Town office.

PAYMENT may be made by mail, in person at the Town Office or at most Financial Institutions through tellers, bank machines, telephone or internet. After hours tax payments may be left in the drop box at the front west entrance door at 37 Sandiford Drive.

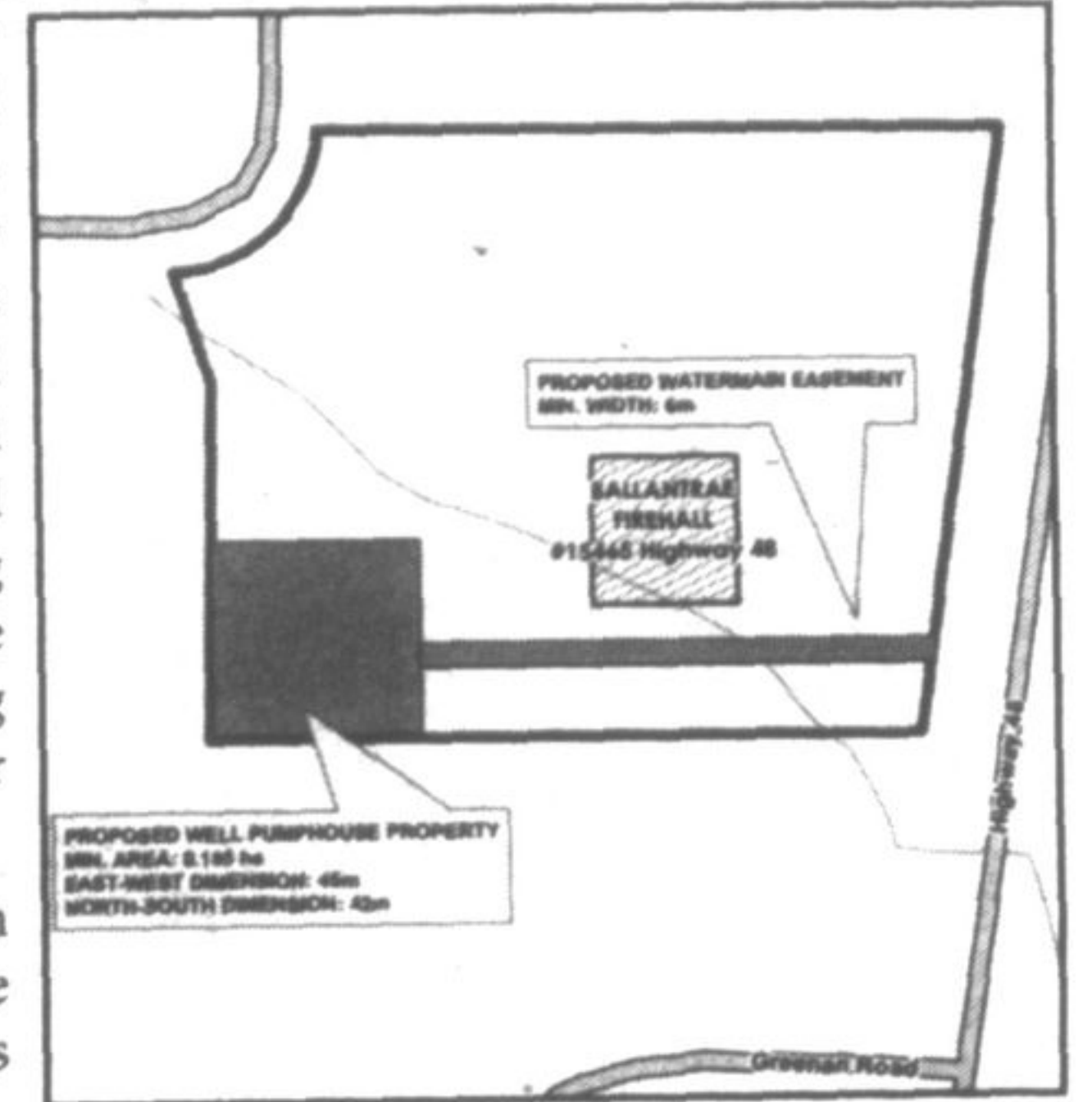
