ARE YOU ON THE VOTERS' LIST?

You can check if your name is on the Voters' List by:

- Using the search function on our website at www.townofws.com/Voters_ List.asp
- Visiting the Clerk's Department or the Whitchurch-Stouffville Public Library

WHAT IF MY NAME IS NOT ON THE VOTERS' LIST (or the information is incorrect)?

If you have recently turned 18; changed your name as a result of getting married/divorced; or moved, chances are that your electoral information will not be reflected correctly on the Voters' List. If changes are required, you should try to make the changes prior to Election Day by completing an Application to Amend the Voters' List (form 10-WS). This will ensure that you receive your Voter Notification Card in the mail and you will avoid delays at the poll.

An Application to Amend the Voters' List form (form 10-WS) is required to:

- Add the applicant's name to the list
- · Correct the applicant's information on the list
- Delete the applicant's or a family member's name (deceased, moved, other)
- Revise the applicant's school support status

You must present an original or certified or notarial copy of a document showing your name, qualifying address and signature to amend the Voters' List and to vote. Photocopies will not be accepted.
