THE FINAL INSTALLMENT OF REALTY TAXES IS DUE SEPTEMBER 24, 2010 AND 2010 FINAL COMMERCIAL, INDUSTRIAL & MULTI-RESIDENTIAL TAX BILLS

1st Installment Due - September 24, 2010
2nd Installment Due - October 22, 2010

COMMERCIAL, INDUSTRIAL & MULTI-RESIDENTIAL TAX bills have now been mailed. Ratepayers who have not received their bills should make immediate application to the Municipal Tax Department.

THE PENALTY charged for non-payment of 2010 taxes is one and one-quarter (1 1/4) percent imposed on the first day of default and on the first day of each month thereafter.

FAILURE TO receive a tax bill does not eliminate the responsibility for payment of taxes nor the penalty charges for late payment.

TAX PAYMENTS may be made by mail, or in person at the Town Office and at most Financial Institutions through tellers, banking machines, by telephone and Internet banking. Banking fees may apply. Penalty will be charged and added to your tax account at our office on payments made at the bank after the due dates. After hours tax payments may be left in the drop box at the front west entrance door at 37 Sandiford Drive.

VACANCY REBATE APPLICATIONS are available at the Town offices during business hours, for any commercial or industrial properties that have been vacant for 90 consecutive days. The deadline for submitting the application for the 2010 taxation year is February 28, 2011.

YARD WASTE COLLECTION

All yard waste material except brush must be placed in paper yard waste bags or an open top container (excluding cardboard boxes). Clear, opaque or orange bags will not be collected.

Yard Waste is collected bi-weekly on Mondays from April to November. Please refer to the collection schedule for the yard waste collection days for your area. A copy of the schedule can be obtained from www.townofws.com

Materials acceptable for collection include leaves, plants, fine brush, tree clippings, branches. Branches are not to exceed 100 mm (four inches) in diameter, and shall be tied in bundles of a maximum length of 1.2 metres (four feet), and weighing no more than 22 kgs (fifty pounds). Please do not use wire to tie bundles.

Materials not accepted include grass clippings, stumps, root balls, rocks, food and kitchen wastes, animal droppings, fruit and vegetables, driveway and road sweepings.

Residents who wish to drop off their yard waste (including grass clippings) may do so, free of charge, at the Miller Waste Composting Facility, 1351 Bloomington Road, Richmond Hill (just west of Leslie Street) Monday to Saturday - 7:30 a.m. to 5:00 p.m. (closed Statutory Holidays).

ARE YOU ON THE VOTERS' LIST?

You can check if your name is on the Voters' List by:

- Using the search function on our website at www.townofws.com/Voters_List.asp
- Visiting the Clerk's Department or the Whitchurch-Stouffville Public Library

WHAT IF MY NAME IS NOT ON THE VOTERS' LIST (or the information is incorrect)?

If you have recently turned 18; changed your name; or moved, chances are that your electoral information will not be reflected correctly on the Voters' List.

In order to add your name or change your information, you must present an original or certified or notarial copy of a document showing your name, qualifying address and signature to amend the Voters' List and to vote. Photocopies will not be accepted.

1. Visit the Clerk's Department during regular business hours (Monday to Friday 8:30 a.m. to 4:30 p.m.) and election staff will assist you
2. Election staff will be available to process Application to Amend the Voters' List 11-WS) and Proxy forms (Form 3):
 - Saturday September 25th - 12:00 noon - 4:00 p.m. Lebovic Centre, 30 Burkholder Street, Stouffville
3. Complete a form at one of the Advance Votes - October 16th, 18th, 19th or 20th (see website for details & locations) OR
4. Complete a form at the poll to vote on Election Day - October 25th, 2010

PLEASE NOTE: The Clerk's Department cannot process applications received after October 20th, 2010. After that time, you must add your name to the Voters' List at the voting place.
