On March 2, 2010, Town Council adopted By-law 2010-001-ZO, a new Comprehensive Zoning By-law for the Town. The By law was approved by the Ontario Municipal Board in a decision dated January 13, 2011. By law 2010-001-ZO is the Town's Comprehensive Zoning By-law that establishes the permitted uses and regulations for all lands in the Town

The proposed amendments address a number of matters that have been identified as requiring adjustment through the use of the by-law in the development process and through further review. These amendments are organized under Administrative/ General Amendments, provisions related to Residential Zones, Commercial Zones, Mixed Use Zones, Employment Zones, and corrections to the By-law text and mapping Schedules.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the

Corporation of the Town of Whitchurch Stouffville before the By law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.



GOVERNMENT: 'Crowded' Hoover Park Dr. facility permanent

Dogs look for more leash-free parks

Local canines have given Stouffville's first off-leash park their tail wag of approval, as has the town, which has decided to make it permanent.

But it hasn't been all puppy romps and ball chases.

"There has been some bites and blood drawn on the animals," Mark Riden, spokesperson for the Stouffville Dog Owners Association told council April 5. "It's an at-yourown-risk park."

The association operates the park in conjunction with the town.

Despite that, Mr. Riden said no complaints have been received by the town regarding the park.

"Our existing park is crowded and probably putting a stress on the actual site," he said.

Which is why the association wants the town to construct two more off-leash dog parks, one in the Musselman's Lake/Ballantrae area and another in Bethesda Park, which currently has soccer pitches and ball diamonds on it.

"The location is very good to allow access to the reservoir trails," Mr. Riden said.

That may be, but Councillor Susanne Hilton predicts a potential problem.

"Seeing kids running up and down a field. You know where that dog's going to go, chasing that ball," Ms Hilton said.

A second or even third park, while not out of the question, is not on the town's current to-do list.

"Good on them as an organization. It's

good that they're thinking about the future and where do we go to next," said Mike Richardson, manager of facilities and parks for the Town of Whitchurch Stouffville.

Since the park opened about a year ago, Mr. Riden said the number of dogs running free in other parks and recreation areas within the municipality has been reduced.

Not so, according to Mayor Wayne Emmerson.

"We still do have issues with running at large," he said, noting six dogs were on the trails, off-leash, behind his home just prior to that evening's council meeting.

Last fall, the association estimates the park, which is located on Rougeview Avenue behind Staples in the Smart Centres plaza on Hoover Park Drive, had 100 daily users. That number dropped to 50 during the winter.

"(Which was) surprising to us we had a fair number of users in the park," Mr. Riden said. "In our opinion, the first park has been a huge success."

Along with two more parks, the association wants the current one-acre facility enlarged to accommodate separate areas for the smaller and senior dogs.

Mr. Richardson said when the town installs the permanent fencing this spring, there will be an opportunity to enlarge it slightly but "we just don't see how we can accommodate both of those requests at this time".

Before any expansions or changes to the park's current layout are made, the issue will be brought before council for final approval. Mr. Richardson expects that to take place next month.
