COUNCIL'S CORNER

Council Highlights provide a brief summary of pertinent decisions made at a Council meeting. More information on these stories and other Council activities can be obtained from the Town's website.

COUNCIL APPROVES A LOAN UNDER THE TOWN'S COMMUNITY IMPROVEMENT PLAN

Council approved a loan requested from The Meat Merchant Inc., a butcher/meat retail business on Main Street, under the Town's Community Improvement Plan (CIP). The loan will assist the owner with the purchase and installation of an awning as well the staining of the store's exterior façade.

As part of the Town's 2011 Operating Budget, Council set aside \$50,000 to fund Downtown Stouffville CIP projects. In October 2011, The Downtown Stouffville Working Group reviewed the Loan application from the owner of The Meat Merchant Inc. and recommended that Council approve the Loan request.

Under the approved agreement, the Town will provide zero interest financing for up to 50% of the value of the project (up to a maximum of \$2,086). The agreement also indicates that the loan program will have a maximum term of ten years and be repaid at any time with a 25% loan forgiveness if repaid within the first three years.

The Town's CIP is an innovative and effective way of stimulating the Downtown core by providing businesses with the necessary tools for redevelopment and revitalization. With \$45,545 available in the Town's 2011 budget for CIP related projects, Downtown Stouffville businesses are encouraged to contact Anna Rose at 905- 640-0749 to learn more about how the CIP program can be of benefit to their business.

COUNCIL RENEWS THE FIRE PROTECTION AGREEMENT WITH TOWN OF NEWMARKET

Council approved the updated Fire Protection Agreement with Central York Fire Services (Newmarket and Aurora) for the next five years. The Agreement provides for first response services to the north west area of Whitchurch-Stouffville.

The original agreement was approved by Council in June 2006 and had come to the end of its term. The new document contains minor housekeeping updates, including revised costs for the first response fire protection to the area (called the annual retainer) and for a charge per call. In 2011, the total cost of these services was estimated to be \$175,000.

In 2010, Central York Fire Services responded to 29 incidents, within the Agreement area, that were related to vehicle accidents/ rescue calls on Highway 404. Collaborating with surrounding municipalities on fire protection is a common practice across Ontario and is often an effective way of providing protection in outlying areas of the Town. Concurrent with this arrangement, the Town of Whitchurch-Stouffville continues to develop and enhance its composite fire services.

COUNCIL HIGHLIGHTS CONT'D

COUNCIL WAIVES REQUIREMENTS IN THE NOISE BY-LAW TO FACILITATE CONSTRUCTION OF NEW SCHOOL

Council waived the requirements in the Noise By-law to allow contractor, Torcom Construction Inc., to complete concrete work at the new Wendat Village Public School. The York Region District School Board is planning to move ahead to construct this new elementary school on Reeves Way Blvd., near 9th line.

Under the Noise By-law, construction activity is allowed between the hours of 7:00 a.m. to 7:00 p.m. (Mon. to Sat.). Construction activity is not to occur outside these hours, including on Sundays and Statutory Holidays.

The contractor requested that certain requirements be waived to facilitate the completion of concrete work between 9:00 p.m. and 7:00 a.m. for November and December 2011. Council waived the requirements for Torcom Construction Inc. provided that they give a 48 hours notice to the Town and affected residents.

TOWN PROVIDES INFORMATION TO PUBLIC ON 2012 BUDGET

On October 25, 2011, Council held a special budget consultation meeting (open forum) for residents to provide input on the upcoming 2012 Budget. Background information was provided on the factors affecting Town expenditures and services, including provincial requirements, growth related changes, service level changes and costs associated with fiscal decisions made in previous years.

The public had the opportunity to provide their comments, suggestions and wish lists, which Staff will take into consideration when preparing the draft Budget.

The draft 2012 Budget is scheduled for public release on December 6, 2011 and is expected to receive approval in January 2012. Another public open forum is scheduled for December 15, 2011, with a proposed final budget deliberation date set for January 24, 2012 (and January 25, 2012 if necessary).


