DECEMBER 13, 2011 COUNCIL MEETING HIGHLIGHTS

COUNCIL'S CORNER by ANDREA D'SOUZA

Council Highlights provide a brief summary of pertinent decisions made at a Council meeting. More information on these stories and other Council activities can be obtained from the Town's website.

COUNCIL RECEIVES UPDATE ON BETHESDA SPORTS PARK FIELD HOUSE

Council received an update on the construction project for the Bethesda Sports Park Field House and its proposed opening for the 2012 season.

The Field House is designed to be a 3,430 square foot change and washroom facility to support the existing Bethesda Sports Park (located on the south side of Bethesda Road, midway between the Ninth Line and Tenth Line).

In March 2011, Scott Builders Inc. was the contractor awarded for the Bethesda Sports Park Field House construction project and commenced work on May 30, 2011.

As of December 9, the Field House was substantially completed with total costs amounting to \$689,919 (approximately \$8,000 under budget). Remaining funds from previous budgets of this project will be used to finish off landscaping, signage and other work to offer a wide variety of amenities on site.

The Bethesda Sports Park Field House is expected to be available for operational use in the Spring of 2012 and will serve as a valued asset to the Bethesda Park Complex.

COUNCIL APPROVES EXEMPTIONS FROM SITE PLAN CONTROL

Council considered and exempted three developments from site plan control. Two of these projects were for exemptions to existing residential dwellings: one at 39 Victoria Street and one at 95 Russell Street. In both instances, the additions were determined to be in general harmony with the neighbourhood and in accordance with provisions of the Zoning By-law and Community of Stouffville Secondary Plan. On this basis, it was determined that there was no benefit to the Town requiring a site plan agreement to control the development of these sites.

The third exemption involved the Northern Gate Retirement Community at 12427 Tenth Line and a proposal to replace a residential dwelling with an administrative building for the complex and to make other minor changes to the layout of a residential unit. In this instance, new proposed adjustments to the existing site plan are internal to the project and minor in nature not necessitating an amendment to the existing Site Plan Agreement for this site.

Site Plan Control is a development tool exercised by municipalities to implement the Zoning By-law and Official Plan for certain types of development to ensure that the site design is appropriate and in harmony with surrounding uses. Development, which is subject to site plan control, cannot occur unless the Town has reviewed and approved certain plans. Once the plans are approved, a Site Plan Agreement is generally executed to control the form of development.
