

Gormley murder back in court

Paul Kenyon is headed back to court.

A pre-trial hearing is set for Monday in Newmarket.

A mistrial was declared in the case back in April 2012 when Mr. Kenyon parted ways with his lawyer, Ken Murray.

Mr. Kenyon, who is accused of second degree murder in the death of his then-girlfriend Marion Deacon, then hired Newmarket's Leo A. Kinahan. Mr. Kinahan has since left the case.

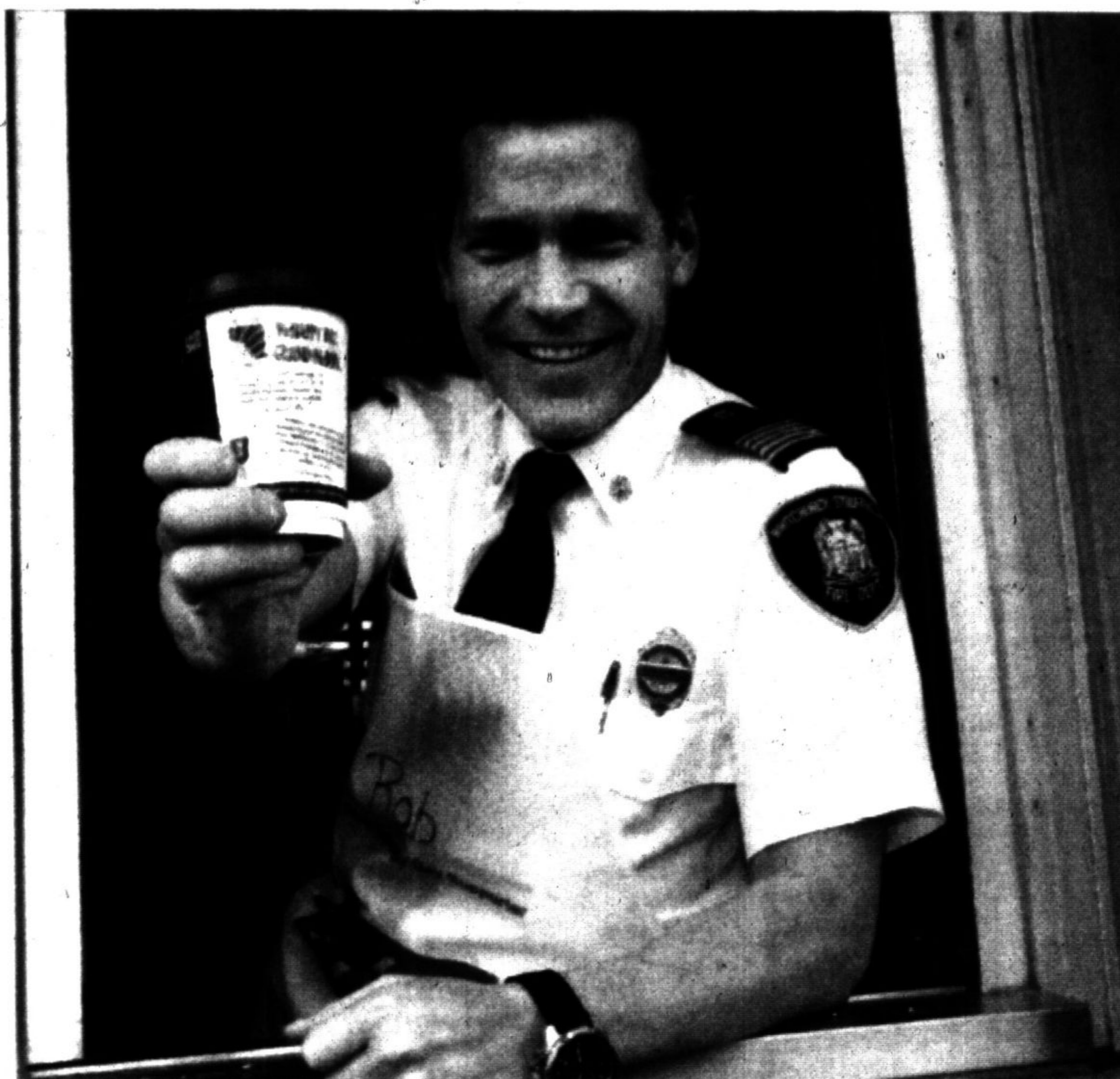
Around 8 a.m. March 7, 2010, York Regional Police and the Whitchurch-Stouffville Fire and Emergency Services were called to a fire at the Deacon home at 6 Doner St. in Gormley.

Mr. Kenyon was found outside the residence and conscious.

He was transported to a hospital with non-life threatening injuries.

Firefighters found Ms Deacon, the mother of three girls, inside the home with no vital signs.

The post-mortem examination revealed she died of multiple blunt-force injuries to the head.
