### HIGHLIGHTS FROM THE MAY 21 COUNCIL MEETING

## COUNCIL ADOPTS TOWN'S FIVE-YEAR ACCESSIBILITY PLAN

Council approved the Town's multi-year (2013 to 2017) Accessibility Plan. The multi-year plan ensures ongoing compliance with provincial legislation and builds upon previous plans designed to eliminate a variety of barriers for individuals with disabilities. Under the Ontarians with Disabilities Act, 2001, all municipalities are required to prepare an annual accessibility plan. This act works towards the prevention, identification and removal of barriers that restrict opportunities for people with disabilities. Complementing this legislation is the Accessibility for Ontarians with Disabilities

Act, 2005, which sets out accessibility standards that are being implemented in stages to achieve an accessible Ontario by 2025.

### COUNCIL APPROVES PLAN FOR ADDITION TO A COMMERCIAL PLAZA AND A NEW APARTMENT BUILDING

Council approved a Site Plan Control Agreement, Zoning Bylaw Amendment and Official Plan Amendment received by Belcomo Properties Limited and Belcomo Investments Limited. This permits a one story addition to the two story commercial plaza located at 5402 Main Street, Stouffville and a seven storey apartment building located at 25 Baker Hill Boulevard (Northwest corner of Main Street and Baker Hill Boulevard). The residential building will contain 139 units. The proposed plans are consistent with the policies and guidelines of the Stouffville Secondary Plan and the Community of Stouffville Urban Design Guidelines.

### **GROWTH MANAGEMENT STRATEGY UPDATE**

In June 2012, Council authorized a two-step study process to examine the long-term land needs of the Town to the year 2031. Step 1 was the preparation of a Growth Management Strategy/ Land Inventory and Capacity Analysis report. Detailed planning and consultations had taken place within the community including three Public Information Centres.

Council received the Growth Management Strategy report (Step 1) as prepared by Watson & Associates Economists Limited and approved the consultants recommended Growth Option, More Compact -Scenario 1 (More Compact Greenfield). Under this scenario, the developable lands within the Phase 3 development area of Stouffville will be required. Council agreed to proceed with Step 2, a Secondary Plan Amendment study process for urban expansion into the Phase 3 lands in the Community of Stouffville.

### COMMUNITY OF STOUFFVILLE COMMERCIAL POLICY UPDATE DIRECTIONS REPORT ADOPTED

Council approved the Community of Stouffville Commercial Policy Study Directions Report prepared and received by consultants Macaulay Shiomo Howson Limited and W. Scott Morgan & Associates. The update includes the assessment of growth implications to date on commercial districts and examines commercial land use requirements to the year 2021. Key elements of the study include a comprehensive market retail analysis and a community consultation strategy.

As part of Council's approval, Business Services have been added as a permitted use in all Employment Business Park land use designations as stated in the Community of Stouffville Secondary Plan. It was also recommended and approved that the corresponding Employment Business Park (EBP) zones under the Zoning By-law 2010-001-ZO, and that the EBP(6) zone (Gottardo Lands) be amended to include Accessory Restaurant as permitted use.


