### COUNCIL HIGHLIGHTS

#### COUNCIL ADOPTS CORPORATE COMMUNICATIONS PROGRAM

Whitchurch-Stouffville Town Council adopted a Corporate Communications Program which is designed to articulate a vision for communications and better align the practices across the corporation. A Communications vision, mission and guiding principles have been adopted and high level projects for 2013 and 2014 have been established. Some of these initiatives include the

### COUNCIL ADOPTS FINAL DESIGN FOR THE MEMORIAL PARK SKATEBOARD PARK

Council adopted the final design for the new Skateboard Park in Memorial Park. Extensive public consultations have been conducted by Design Consultants, Vander Zalm & Associates Inc./New Line Skateparks Inc. and excellent feedback was received by residents in determining the final design for the park.

The new design is approximately 10,100 square feet and incorporates a flat street course and a dedicated bowl area. It will also incorporate a subtle blend of natural elements and mimic a desired street feel including stairs, grid rails and more. The design is compatible for both skateboarders and BMX bike riders and provides elements to satisfy both users and different age groups.

## COUNCIL'S CORNER - CONT'D

Town staff are now set to proceed with the tendering of the construction phase. Construction will begin shortly after the July tender is awarded and is expected to be completed in approximately 12 weeks. Costs for the new skateboard park have been approved in the 2013 Capital Budget including Mayor Emmerson's fundraising initiatives. Pending the final bid submissions and pricing, the park may be expanded to 11,100 square feet should the design come in below the approved budget.

### COUNCIL RECEIVES REPORT ON PROPOSED GO TRANSIT TELECOMMUNICATIONS TOWER

Council received a report for the GO Transit Telecommunications Tower proposed to be located at the Lincolnville GO Transit Station at 13190 York Durham Line. The Tower will be used by GO Transit for its own communications system to provide more efficient and precise control of train traffic.

Town protocol required the proponent to consult with surrounding landowners, public agencies and residents. A community meeting was hosted by GO Transit at Nineteen on the Park on April 16. A follow-up letter, minutes to the meeting and the applicant's response to public comments have been provided to the Town and residents who registered at the meeting have received follow-up correspondence from GO Transit. The applicant has fulfilled the requirements of the Town's Telecommunications Tower Protocol.
