# **COMMUNITY PROFILE SHOWCASES TOWN'S BUSINESS COMMUNITY AND INVESTMENT OPPORTUNITIES**

Whitchurch-Stouffville Town Council received an overview of the Town's new Community Profile publication. As part of the 2009 Council approved Economic Development Strategy, the Community Profile is designed to engage business and investment stakeholders by providing them with a comprehensive profile of the Town's Economic Development services, community demographics, industry sectors, throughout the creation of the publication to effectively in the report to Council available on the Town's website.

### COUNCIL APPROVES AMENDMENTS TO TOWN'S OFFICIAL PLAN AND ZONING BYLAW IN COMMUNITY OF STOUFFVILLE COMMERCIAL POLICY STUDY

In March 2012, Whitchurch-Stouffville Town Council awarded consultants Macaulay Shiomi Howson Ltd. and W. Scott Morgan & Associates to undertake a review and recommended updates to the Community of Stouffville Commercial Policy Study. The original study was conducted by the Town in 2005. The update assessed the implications of growth on the commercial districts and examined commercial land use requirements to the year 2021. A detailed market analysis was conducted as part of the update and input from Town departments as well as members of the public were received to help determine the necessary modifications to the commercial regulations in the Town's Zoning Bylaw.

Council approved the recommended amendments to the Town's Official Plan, Community of Stouffville Secondary Plan and the Town's Zoning Bylaw in relation to the Commercial Policy Study. A recommendation regarding automotive repair and service related uses on Sandiford Drive and Ringwood Drive was pulled for separate discussion in order to provide the business owners in this area with an opportunity to provide investment proposition and local business environment. feedback on this recommendation prior to implementing the Business and community stakeholders were involved new changes. ### **EXEMPTION OF DRAFT PLAN FOR STANDARD CONDOMINIUM APPROVED FOR 38** INNOVATOR AVENUE

Whitchurch-Stouffville Town Council approved a request from Gottardo Construction Limited for an Exemption from Application for Draft Plan of Condominium for the approval of a Standard Condominium. As required, the standard condominium will consist of 10 multi-use industrial units, 82 parking spaces and 10 loading spaces. The lands, subject to the planning application, are situated on the west side of Mostar Street, north of Innovator Avenue (38 Innovator Avenue). The form of development is consistent with earlier approvals granted by the Town in establishing the form, scale, character and conditions of the development.


