You deserve chance to pick your regional chairperson

ISSUE

Another attempt to give voters the right to elect our chair has been delayed at Queen's Park

f you're asking Santa for more accountability from York Region council this Christmas, you're likely going to be disappointed.

Last February, Liberal Oak
Ridges-Markham MPP Dr. Helena Jaczek introduced a private
member's bill aimed at giving
you the power to vote for the
regional chairperson, changing
the current practice that has
the vote of a majority of the 20
council members appointing
someone to the job at the inaugural meeting of each term.

The path to more democracy in York Region has been a winding and rocky one.

Dr. Jaczek's bill is essentially a resurrection of a bill. introduced by Liberal colleague Richmond Hill MPP Reza Moridi, that floundered in October 2012 when thenpremier Dalton McGuinty crowned his resignation with prorogation of the legislature. It marks the second time third, if you count former MPP David Caplan's proposal to make the chairpersons of all regions elected — that an MPP has introduced a bill intended to shake up the status quo.

Dr. Jaczek's bill passed second reading by a unanimous vote June 6 and referred to the standing committee on the legislative assembly, where it has sat ever since and isn't scheduled to be dealt with prior to the legislature's holiday break.

So, unless something miraculous happens, the bill won't receive third reading in time for the 2014 municipal election. That's a lump of coal in the stockings for York's 1.1 million residents.

The time is well past for direct accountability to the

electorate for the powerful position of regional chairperson and "chief executive officer" of York Region.

Currently, regional chairperson Bill Fisch, who is paid in excess of \$212,000, is essentially the face of our region at regional and provincial functions and events.

The chairperson typically sets the agenda for each term and casts the tie-breaking vote any time there's a deadlock on council, including matters relating to the nearly \$3-billion annual budget.

Halton, Waterloo and now Durham region have successfully followed this path to democracy.

At this point, though, all the pros and cons are moot even a deluge of public pressure won't likely get this bill passed third reading before next Thursday.

We'd be lucky, in fact, to see it in place for the 2018 municipal election. That's unacceptable.

We are calling on our MPPs
— who, of all stripes, supported this bill last spring — to
do everything in their power to
get it passed before heading off
for the holidays.

If they're not up to the task, then regional council should recognize the way the winds of change are blowing and opt to move forward themselves on the reform as their counterparts in Durham did recently.

The latter course of action still won't have an impact in time for next year's municipal election, but it would recognize the need for accountability to voters.

If neither of those things happen, York residents are within their rights to label the lot of them the Grinches who stole democracy.

BOTTOM LINE: MPPs owe it to York voters to pass bill before heading home for holidays.

Are we being taxed on taxes?

We complain about the high cost of gasoline and wonder if the government can do anything about it.

Well, it can by stopping the tax on taxes.

Let me explain.

Recently, instead of filling up the car, paying and discarding the sales slip, I took a look at the slip. Total cost \$59, total taxes \$18.75. Therefore, the cost of gasoline was \$40.25.

Last tax listed was HST, total \$6.79. But 13 per cent of the fuel cost (the goods or service received) is \$5.23.

Why the difference? If the federal excise tax and provincial fuel tax is added to the cost of the fuel, the total is \$52.21 and 13 per

cent of this value is \$6.79. The way I read it, we are being charged HST on tax! That is, we are paying tax on taxes for fuel.

The \$1.56 overpayment in tax was for 43.403 litres, which means we pay 3.59 cents per litre.

The way I read it, we are being charged HST on tax!

The governments can lower the price at the pump by this amount. I will assume a similar tax on tax is charged on diesel.
