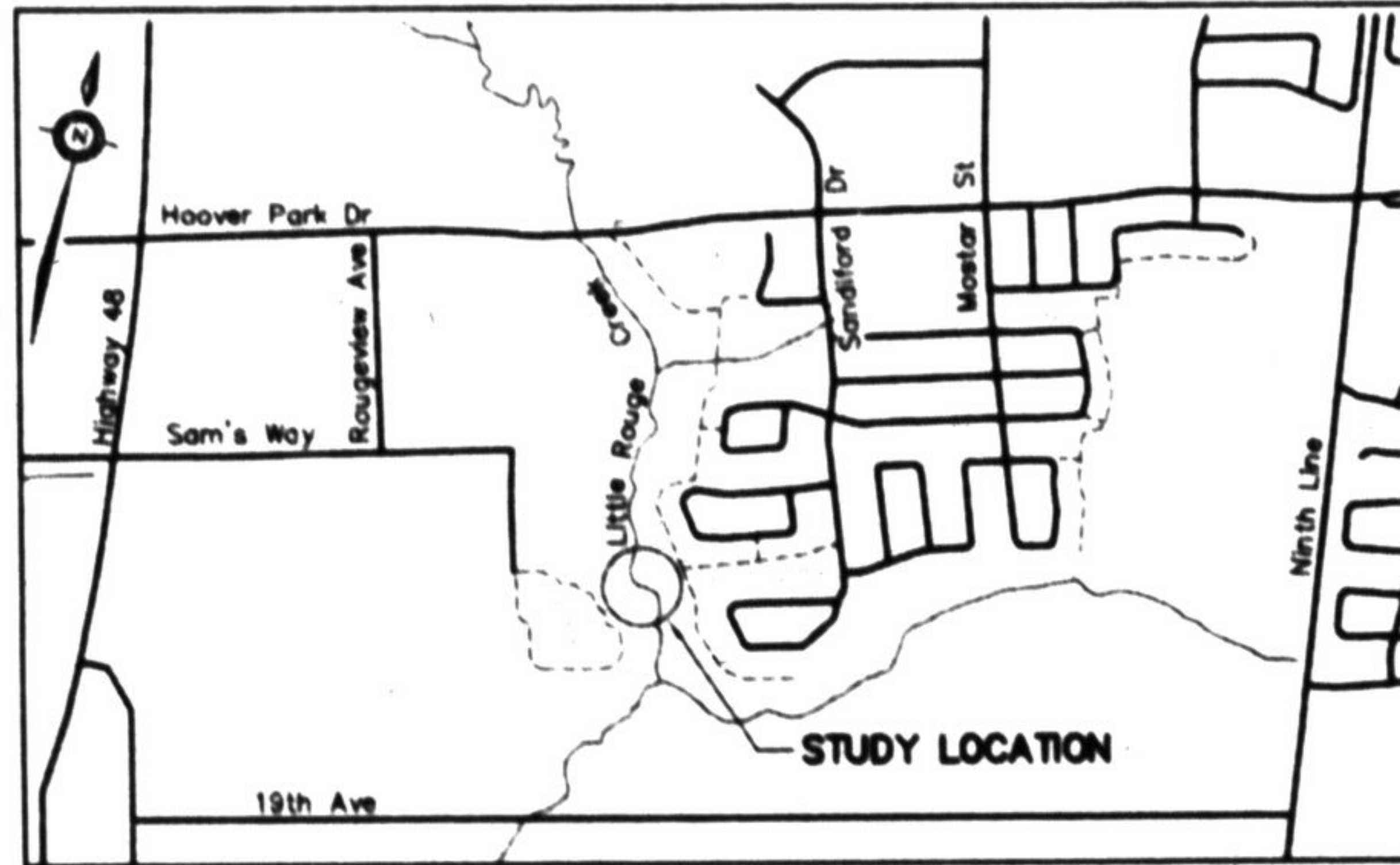




## NOTICE OF STUDY COMPLETION Pedestrian Trail Bridge Crossing of Little Rouge Creek Class Environmental Assessment Study

### THE STUDY

The Town of Whitchurch-Stouffville, through their engineering consultant Chisholm, Fleming and Associates, has completed a Class Environmental Assessment for a proposed pedestrian trail bridge crossing of the Little Rouge Creek. The proposed bridge will connect to existing recreation trails and provide continuity to the overall trail network, as identified in the Town's trail map.

This project has been carried out in accordance with the requirements for a Schedule 'B' project as outlined in the Municipal Engineer's Association (MEA) *Municipal Class Environmental Assessment* (October 2000, as amended in 2007 & 2011), which is an approved process under the Environmental Assessment Act.

The study has reviewed the need and justification for the proposed trail bridge, assessed alternatives to the undertaking and presented the technically preferred solution.

Subject to comments received as a result of this Notice, and the receipt of necessary approvals, the Town intends to proceed with the design and construction of this project. 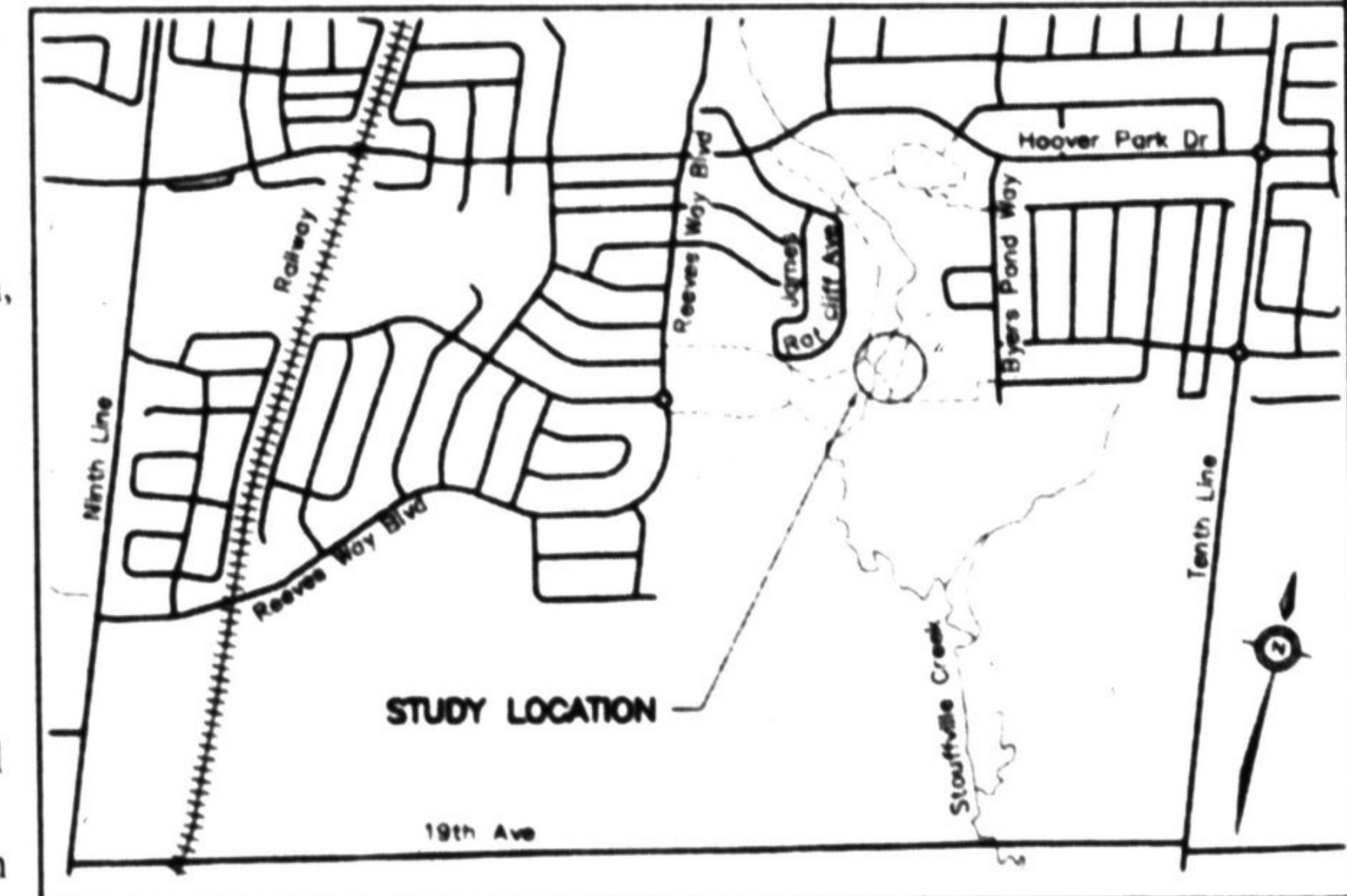
