

Stouffville NASCAR team ninth in Quebec event

Jason Hathaway drove the Stouffville-based EHR-Team Three Red Rockstar Energy Drink-Fast Eddie Chevrolet to a ninth-place finish at the NASCAR Canadian Tire Jiffy Lube 100, presented by LaPette Bretonne race at Circuit ICAR in Mirabel, Que. Sunday.

Starting the 30-lap race on the 2.113-mile, 16-turn road course in the 10th position, Hathaway finished the race, which featured one caution for two laps, up one position into ninth overall.

Andrew Ranger took the checkered flag.

By virtue of his top 10 finish, Hathaway is currently in a two-way tie in fourth place in the standings with 103 points.

J.R. Fitzpatrick leads the standings with 122 points.

The series is to resume in Weataskiwin, Alta. with the running of the inaugural Alberta Has Energy 300 race at the Edmonton International Raceway, Friday.

Barker earns top 10 placings on track

The Stouffville resident and Stouffville District Secondary School graduate, who trains with the York University Track Club, was sixth in the men's discus with a toss of 43.02 metres.

Barker's teammate Trevor Greenwood won the event with a toss of 45.40m.

Also competing in the shot put, Barker finished ninth with a best effort of 13.48m.

Eli Pawliw of the University of Windsor Track Club won the event with a throw of 17.04m.
