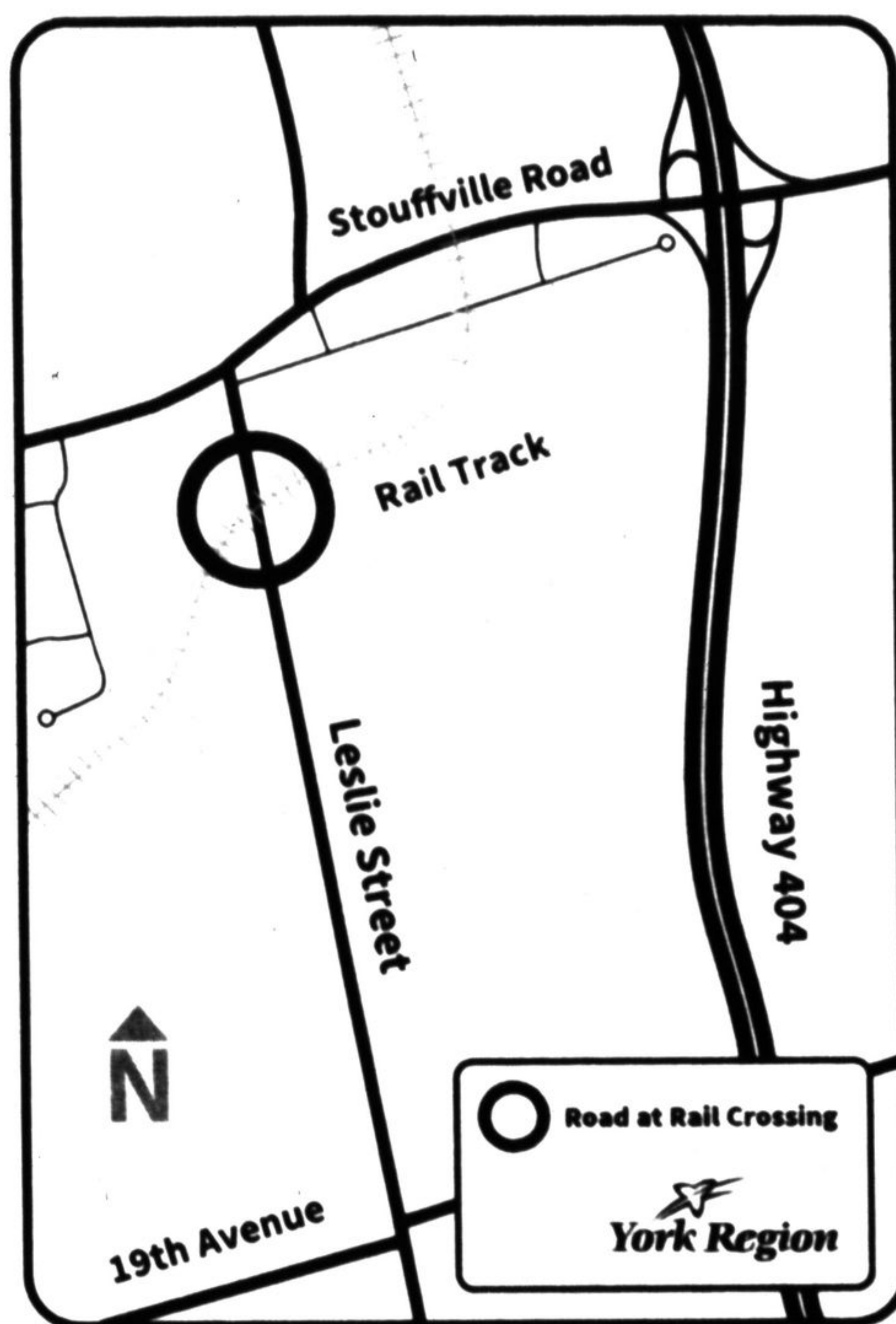

**NOTICE OF TEMPORARY ROAD CLOSURE**  
**Rail Crossing at Leslie Street**  
**South of Stouffville Road**  
**in the Town of Richmond Hill**

Improvements are being made to the rail crossing on Leslie Street, south of Stouffville Road, to accommodate a second track at the crossing and improve travel for road users.

To complete this work, the rail crossing will be closed from Monday, August 11, 2014 to mid-September 2014. Access to local traffic will be maintained.

A signed detour route will be implemented during construction.

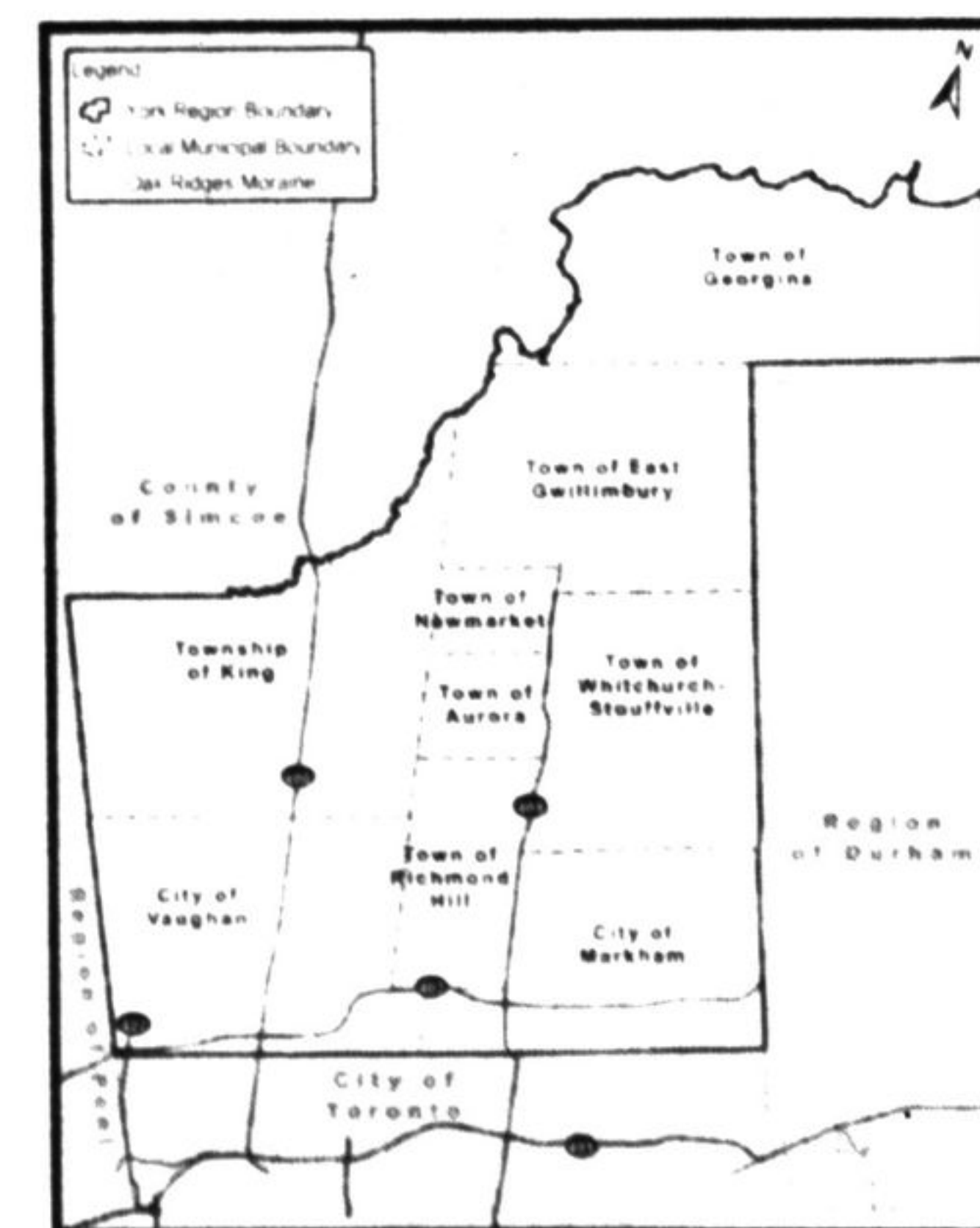
**Share Your Ideas About What Water Means to You!**
