TUESDAY, AUGUST 19, 2014 TOWN BY-LAW OFFICER AND KNIGHTS OF **COLUMBUS RECEIVE ACCOLADES** FOR COMPASSION

Town Senior By-law Officer Linda Mainprize, along with the Knights of Columbus, was recognized by Town Council and representatives of the Character Community Foundation of York Region for exercising compassion while carrying out her duties. Earlier this summer, Mainprize was investigating a neighbour complaint about street parking and an alleged basement apartment issue. She discovered the cars were for the caregivers of a gravely ill child that needed 24/7 care. She also learned the mother and her baby were sleeping in the basement because it was too warm upstairs. Unable to turn a blind eye, Mainprize contacted the local chapter of the Knights of Columbus who

graciously supported the request for assistance and had an air conditioning unit installed within days.

Under Raycroft's tenure, Town services and amenities have grown to include SoccerCity, the Stouffville Clippers Sports Complex, several new parks and trails, as well as enhancements to the Whitchurch-Stouffville Museum.

NEW DIRECTOR OF PLANNING & DEVELOPMENT SERVICES FORMALLY WELCOMED AT TOWN **COUNCIL MEETING**

Steven Kemp, the Town's new Director of Planning & Development Services, was introduced at Council by Town Chief Administrative Officer Andrew McNeely. Kemp has more than 20 years of municipal experience with the City of Toronto and most recently with The Regional Municipality of York.

As a member of the Town's Senior Management Team, Kemp will guide the Town through several important initiatives and challenges, including and overseeing the Town's future growth and upcoming Transportation Master Plan. He formally starts his new position with the Town on September 2.

TOWN TO ASK METROLINX TO KEEP HISTORICALLY SIGNIFICANT STOUFFVILLE GRAIN ELEVATOR AT **CURRENT SITE**

Town Council endorsed a report on the future of the Stouffville Grain Elevator, requesting that Metrolinx keep the historically significant building at its current location.

The report outlines how the Stouffville Grain Elevator represents a locally significant heritage resource which forms part of a cultural

heritage landscape that is significant within the Downtown Heritage Area of the Community of Stouffville. It recommends Town staff, the Whitchurch-Stouffville Heritage Advisory Committee and the Downtown Stouffville Working Group work with Metrolinx to assist the provincial agency in exploring possibilities for end uses as part of the objective to preserve, rehabilitate and repurpose the building.

PROPOSED UPDATE TO SITE ALTERATION AND CLEAN FILL BY-LAW DEFERRED TO SEPTEMBER COUNCIL

The proposed update to the Site Alteration and Fill By-law has been deferred to the September 9th meeting of Town Council. Staff will report back to Council on the revised fee schedule as well as the legacy fee fund.

TOWN TO EXAMINE COMMUNITY GARDENS

Town Council endorsed a report on the development of a community gardens program. Staff will hold community consultations on the preferred location and operating model as part of the Town's 2015 Neighbourhood Park Development program. Staff will report back to Council in 2015 on the feedback obtained through this consultation process.

Community gardens are important neighbourhood spaces that provide health, economic, educational, social, and environmental benefits to participants and the community. Community gardens can provide fresh, healthy, low-cost food; create a social gathering place for the community; and help improve the local environment by preserving and growing green space and by encouraging people to act as local stewards.
