impact on me and hundreds of others, I just hope we can do the same for him.”

As of Wednesday afternoon, \$6,175 had been raised, including \$1,000 from Dale's Gardening and Landscaping, Chartrand's employer.

Another former employer, Glenn Ball, commented about how hard of a worker Chartrand was.

“I'd never have a bad word to say about him,” he told yorkregion.com. “He was always happy-go-lucky and a very hard worker.”

The investigation team includes four investigators, including two forensic specialists. The Ontario Provincial Police, which patrols Hwy. 48, assisted in the investigation, OPP Sgt. Kerry Schmidt said.

It determines whether police have committed a crime and if charges should be laid. It reports the results of its investigations to the Attorney General.
