## Brawl led to machete attack, trial told

The party, attended by more than 100 Stouffville-area teenagers, was supposed to be a celebration of the summer of 2013 in a well-heeled Gormley-area neighbourhood, but turned into a soap opera filled with blood, guns and police sirens.

Now two and a half years later, the trial of the man charged with attempted murder and

weapons charges has begun in the Newmarket courthouse.

Tyler Wirag, then 19, from Musselman's Lake, has been charged with the attempted murder of a former acquaintance, Kyle Sauro, then 20, from Stouffville.

At court, images of the wounds Sauro suffered on that night — a significant gash running from his sternum to his belly button — were shown to the jury.

Of course, as in any trial, there are two different versions of what happened that night.

Furthermore, police never found what is alleged to be the weapon investigators say Wirag used to slice open Sauro on that August 2013 night.

Although they did find what they are
