NOTICE OF INTENTION TO DESIGNATE IN THE MATTER OF THE ONTARIO HERITAGE ACT

R.S.O 1990 Chapter O.18

13523 Mccowan Road (Lemonville Church)

TAKE NOTICE that the Council of The Corporation of the Town of Whitchurch-Stouffville intends to designate the building and lands known as 13523 McCowan Road (Lemonville Church) under Part IV, Section 29 of the Ontario Heritage Act.

REASONS FOR THE PROPOSED DESIGNATION:

Lemonville United Church is considered to be the oldest house of worship within Whitchurch-Stouffville that is still in regular use. The initial services of the Lemonville Methodist Church began in 1854 within a frame school house. In 1856, the original church building was constructed near the present site. In 1869, the church was constructed at the present location. The cemetery has grave inscriptions from as early as 1857, implying it existed at the time of the original 1856 church structure.

In 1954, the Lemonville Church closed due to mounting repair costs and inability to pay the Minister's salary. Still, members of the Women's Association continued their monthly meetings and student ministers continued to visit during the summer. Despite the grave conditions of the church, Marion Rae campaigned the community for its re-opening. In 1957, she organized the 1st formal service since the church's closure. In 1964, the necessary renovations took place and since then congregation members have continued its operations.

The 1.5 story vernacular house at 12140 Tenth Line is known to have been built by Leonard Kester circa 1848 using vertical plank construction, a technique considered rare within the Community of Stouffville and in York Region. It is also believed to be the first dwelling constructed on Tenth Line south of Main Street.
