Driver killed in collision between car, dump truck on Hwy. 48

Stouffville man, 85, dies after being airlifted to hospital

A driver has died after a collision between a car and a dump truck

in the area of Bloomington Road and Hwy. 48 in Whitchurch-Stouffville, Nov. 8.

The incident took place at about 1:56 p.m.

The driver, an 85-year-old Stouffville man, was airlifted to hospital, but he succumbed to his injuries.

Hwy. 48 was closed between Bloomington and Bethesda Sideroad while the OPP conducted a collision reconstruction investigation, OPP Sgt. Kerry Schmidt said.

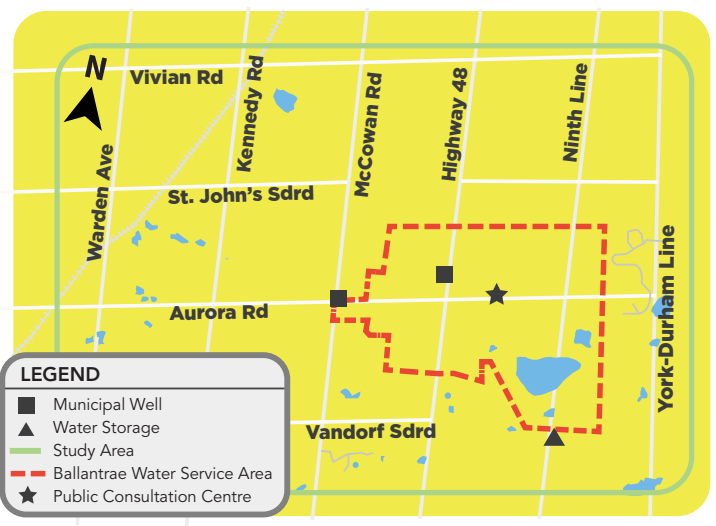

York Region has initiated a Schedule 'B' Class Environmental Assessment (Class EA) under the Municipal Class Environmental Assessment process to better understand if the existing water supply and storage capacity in the Ballantrae-Musselman Lake area will meet the long-term water needs of the community.

As part of the Class EA process, York Region is hosting a Public Consultation Centre on the project to engage residents and stakeholders with respect to this study.

The Public Consultation will provide study background, servicing alternatives, potential impacts, a summary of the process followed, and next steps.
