VERY POPULAR SONG GETS ITS WRITER INTO TROUBLE.

More Automobile Accidents in Chicago—New Toy Prohibited—Misery Caused by Strife Beginning to Show—Burglaries and Assaults.

 Chicago, June 19.—While running at full speed two automobiles collided at the corner of Harrison street and Michigan avenue the other day. The occupants of both autos were thrown out on the pavement. They were all more or less seriously injured, but one, Neil Barabard, who was with his uncle, J. B. Barabard, and the automobiles, was so seriously injured he is not expected to recover. Edward Pine, Dearborn street, shot Frank Gossie twice in the head yesterday morning and fatally wounded him. The trouble arose over the six-year-old child of the wounded man throwing a piece of coal at Pine's wife. Pine resented the act by slapping the child when the father interfered. Edward Browning who lives with the Pines in the flat below Gossie's, is also mixed up in the affair. Both men are under arrest.

John Stark, whose home is on West Fourteenth street, charged the probation officers with taking advantage of his poverty and shoving home to deprive his wife of the custody of their six children. Mrs. Stark had given the youngest child, scarcely a month old, for adoption. She states as her reason for doing this, that she could not care for them all and her husband had deserted her. He, however, returned to the home on Fourteenth street, and stated that he had gone away to make a home for them in a small place. It is said the Stark family have been helped by charitable societies considerably lately, and their present abode is a mere cellar where water stands on the floor in damp weather. Judge Mack of the juvenile court says custody of the children will be retained until the husband and father makes a home for his wife and children. A young girl, nineteen years old, Rosa Conan by name, after writing a letter to Nan Patterson, wherein she sympathizes with that lady and tells her she is in a bad place and asking her help, took poison in Lincoln Park recently. Some people passing saw the girl lying in an unconscious condition under some trees and immediately summoned a policeman. An ambulance was procured and the unfortunate girl taken to a hospital. Dr. Fisher found she was suffering from laudanum poisoning. Dependency was the cause of committing suicide. A new toy in the shape of a toy pistol has been known to attract the attention of Judge Dunne. This pistol is made to discharge matches as projectiles. The barrel is the size of a regulation match, and in order to shoot, the match is placed with the sulphur end protruding. When the trigger is pulled the hammer strikes the match, causing it to explode. The match still keeps burning, when it is dropped, and is considered very dangerous as it ignites any inflammable substance it falls on. Mayor Dunne has prohibited the sale of the toy.

Evidence of the misery and hunger caused by the strike lasting so long, is beginning to show itself. Last Wednesday, Eva McCoy and James McCann were arrested on charges of stealing meat from the wholesale meat store of O'Brien & Patterson on West Lake street. Entrance was gained by picking a padlock on a rear door with a hairpin. Part of the stolen meat was found in the apartment occupied by Miss McCoy in a tenement house on Washington Boulevard. It seems they have been without food for several days and resorted to stealing in order to appease their hunger. Joseph Howard, composer of "The Land of Nod," was seriously injured in an altercation last week with Fred Mills, president Mills Music Publishing company of Chicago. Mr. Mills and the composer were sitting together at a table in a Restaurant, when a dispute arose of the merits of a popular song. It is asserted Mr. Howard struck Mr. Mills and the latter retaliated. When Mills had finished, Mr. Howard was ready for the hospital.

About nine o'clock, Saturday night, an automobile containing Mr. and Mrs. Jerome Kurtzman, E. M. Hartley, Mr. J. Renouy and William H. Hoopes, Jr., chauffeur, ran into the water at the open draw of the Rush street bridge, plunging twenty-five feet into the river. The first three were drowned. Mrs. Renouy was taken to the hospital. Mr. Hoopes says there was no danger signal displayed and nothing to prevent the bridge from being open. This is the second automobile accident resulting fatally within the last four months. Dr. Alice B. Stockham, who is a practitioner in Chicago, and a woman of ability, together with manager in the book publishing house of which she is owner, was fined the other day for circulating improper literature. Dr. Stockham is a woman seventy-one years of age, and is supposed to have reached the age of discretion. She defended herself on the ground that her book was designed to instruct women on matters it is highly important for them to know, but Judge Betha ruled that when the laws were framed it was not believed the general discussion of the marriage relations is advisable, and so Alice was fined \$250 and one third of the costs and her manager \$500 and two-thirds of the costs.
