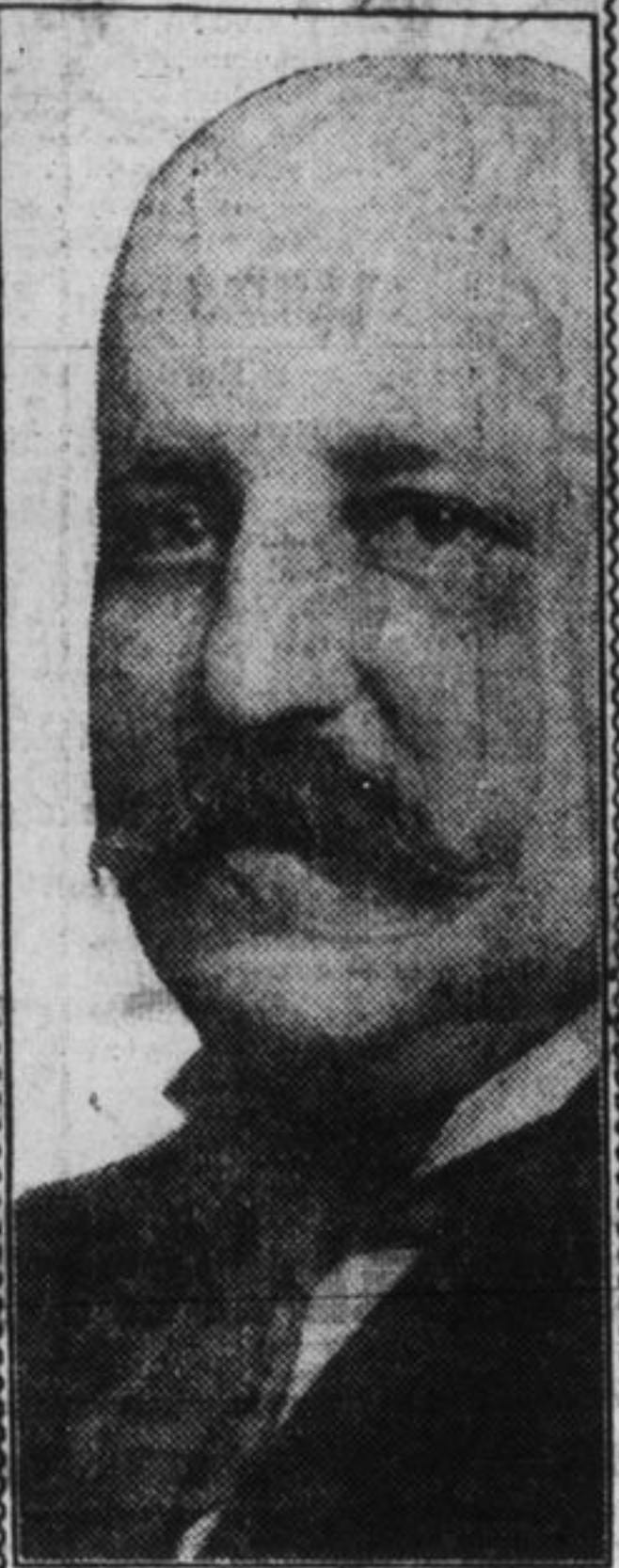

Extortion Charged.

Ald. Polson said he was up against this same proposition thirteen years ago. Local insurance men influenced the aldermen and the council had capitulated again. Ald. Polson held that the city should fight against the robbery of insurance companies, which were charging most exorbitant rates. The Union company had been held down to the surrender of its policy with the city. This company respected the position of the city, and offered to protect it for a further period of time. THE CIVIC INSURANCE CONSIDERED BY THE CITY COUNCIL.

The Renewal Was Left Over for Further Consideration—Discussion Upon the Exorbitant Rates Charged by the Companies.

A special meeting of the city council was held at 9:30 o'clock this morning for the purpose of considering the civic insurance, which had been cancelled by the Union Assurance society. There were present Mayor Saward and Alds. Bassan, Carson, Cooke, Couper, Craig, Elliott, Gaskin, Givens, Millan, Nickle, Polson, Rigney and Ross.

The communication of the Union company regarding cancellation was read; also another from the local agent, C. W. Wright, stating that the company did not desire to place the council in any awkward position, and if necessary, would extend the risk now held by them for five days longer.

The mayor stated that the matter being urgent, the finance committee had considered it and had a report. This report was presented by Ald. Kent, and was as follows:

The Finance Report.

That the \$45,000 fire insurance under the policy cancelled by the Union Assurance society be placed as follows: The sum of \$13,500 divided equally among four non-tariff companies: Company Asset Balance Primum Standard, G. A. Bateman 44.47 Anglo-American, T. J. Lockhart 47.90 London Mutual, J. J. Gardiner 48.00 Montreal, Canada, A. Gardner 48.10 That \$31,500 be divided equally among the tariff companies: British-American, W. H. Godwin 49.47 Alliance, J. P. G. 49.47 Phoenix, (London), H. Howard 64.47 Norwich Union, J. H. Macneil 64.47 Queen, Mills & Cunningham 64.47 Royal, Strang & Strang 64.47 Waterloo Mutual, J. Swift 64.47 Northern, G. J. Larny 64.47 Sun, T. B. P. Power 64.47 The total primum would be \$21,525 in the Union Assurance company.

ing protection to the property they insured, but didn't contribute one cent towards that protection. The city buildings were equipped recently with fire protection, and yet there was no lowering of rates. Ald. Carson stated that it didn't matter whether tariff or non-tariff companies carried the city's insurance, so long as the companies were good. Did the non-tariff companies not pay their losses? He favored giving all the insurance to the non-tariff companies. The city would well go into municipal insurance.

Ald. McCann held that the tariff rates on the city buildings were not exorbitant. He did not think the American companies would reduce the rate on the buildings. Ald. McCann agreed that the council should have more time in which to consider the matter.

Ald. Rigney said that he supported the finance report as the best solution of the question at the present time. Ald. Givens spoke in favor of the tariff companies holding them the safest. He admitted that the rates at present were higher than some years ago, but the insurance companies had not so much money in the hands of Baltimore and Toronto that they had to recoup themselves. THE SPORT REVIEW.

General Notes on the Sports of the Season.

Toronto Telegram: Queen's are fighting shy of the C.R.F.U., while the O.R.F.U. really got it in the neck, are just loving the folks who pulled them into same old way. The professionals of the South of England defeated the amateurs of the south by one goal to nothing in a game which drew 10,000 spectators. The football association handed over £234, the net profits, to the Queen's fund for the unemployed.

In the professional hockey league, Houghton defeated the Canadian Taylor by 6 to 4. During the contest, Taylor deliberately hit Blake over the head with his stick, and was fined \$2 by Referee "Chauncey" Elliott, in addition to being put out of the game.

E. James, the American jockey, who for the past five years has been riding in England and France, is now living in Toronto. He may stay in Canada this season to ride on the northern circuit, after which he will either go back to England or to France.

The three Doyle brothers of the Newmarket O.H.A. intermediate team have quit hockey for the season because of the death of Eddie Doyle, one of the family, at Brantford, as the result of a railway accident at Berlin. This will weaken the Newmarket team considerably, and they may have to drop out of the series.

P. D. Ross of Ottawa, has written Howard Wilson, the president of the E.C.A.H.A., suggesting that the affairs of the Stanley cup, of which he is at present the trustee, be placed in the hands of a committee elected from the E.C.A.H.A., the O.H.A., and the Manitoba and North-Western Hockey Association.

The Manitoba Hockey League ordered the Victoria Portage in the Prairie game to be replayed. The basis of the Victoria's protest was that Portage had a Winnipeg resident (Claude Temple, in goal. The league, however, has no residence rule, and the replaying of the game was ordered because the Portage representation was quite willing.

Capt. Martin, of the Varsity hockey team states that the report of their game on Saturday night against the Technical School, in Pittsburgh, Pa., was an altogether distorted one. The game was strenuous, abounding in tripping and slashing, and Referee Schooley let the players get clean away from him. There was not, however, anything like the swinging for opponents' heads that the report would indicate, and there was no fight or rowdiness.

College football in the middle western states has been dealt a staggering blow by the representatives of the "Big Ten" of western colleges, who after two days' conference recommended many changes for football and other college athletics with a view of curbing professionalism. It was recommended that the games as played at present be abolished as an inter-collegiate and collegiate contest in the "Big Ten" colleges, that the conference await from the American football rules committee such modifications of the playing rules as will free the game from brutality and unecessary danger.

The Eastern Canada Amateur Hockey Association has adopted the following rules from the O.H.A. constitution: Referee must obtain list of players and substitutes; if any, ranking in the game; this is to be supplied by the captains of the competing teams. The referee shall see that the time-keepers, umpires, and penalty time-keeper are in their places before the commencement of a match. He shall have power to appoint them, if the clubs cannot agree upon them. The referee shall have complete control over the game. The referee shall report all cases of unpunctuality in teams, all penalties, and all fouls, and the nature of the sentence. The assistant referee will have power over rough play only. The penalty time-keeper must keep a record of all penalties imposed, and the games scored, and their scores.
