LICENSE-HOLDERS

WAITED ON GOVERNMENT, THIS MORNING.

The Protest Against Some of the Clauses of the New License Act—Government Will Discourage Tied House System.

Toronto, April 4.—About 800 members of the Ontario License-holders' Protective Association waited upon the government, this morning, to protest against some of the clauses of the new license act.

First, it was asked that the clause relating to licensing of bar tenders be stricken out, or if not, that the provision be made for emergencies, such as sickness of bar-tenders or special days.

Any by-laws increasing license fees, they thought, should be submitted at the municipal elections, and the principle applied to cities as to the increase of fees, should apply also to towns, villages and townships.

THE LLOYD TRIAL

WAS PROCEEDED WITH AT BELLEVILLE ASSIZES.

Prisoner An Old Man—Pleaded Not Guilty—His Wife Was Found Dead, With Her Clothes on Fire.

Belleville, Ont., April 4.—The Lloyd murder trial was proceeded with at the assizes here, this morning. Adam Lloyd, the prisoner, is charged with killing his wife, and afterwards trying to burn the body to cover the crime.

The case was traversed from the last assizes. The prisoner, who has been in jail for about eight months, pleaded not guilty. He is defended by E. G. Porter, M.P., E. Meredith, K.C., of London, is the crown prosecutor. He laid the case before the jury in a powerful way.

NEW MINING POLICY

May Prove a Favorable Departure.

Toronto, April 4.—The Globe today says: "The Ministry has announced a mining policy that may prove a favorable departure in provincial administration. The right of way of the Temiskaming and Northern Ontario railway passes through about three and a half miles of rich mineral land, and the reports to the department show that many of the deposits over which the road is built are very valuable."

This asset of the province will be disposed of by tender, the conditions being: (a) a rental of \$20,000 per year for a term of 50 years, or more, if the land is not worked, and a minimum royalty of ten per cent. on ore valued at less than \$100 per ton, 25 per cent. on ore valued at from \$100 to \$1,000 per ton, and 50 per cent. on ore as is valued at more than \$1,000 per ton.

ANNUAL CHEESE MEETING.

Sydenham Factory Was Successful.

The annual cheese meeting of the Sydenham factory was held on March 19th, with George Freeman, chairman, J. Blake, secretary, R. B. Cochrane, proprietor, manufactured milk into cheese at one cent a pound; butter at three cents a pound, to the patrons, and paid all expenses. The factory will start April 2nd. It has sixty patrons. Total pounds of milk, 2,645,764; total pounds of cheese, 256,932; amount of money, \$26,800; average pounds of milk per pound of cheese, 10.32; average price per pound of cheese, \$10.51; average price per cent. of milk, net, \$92.15; average price per ton net, \$15,43; cost of making, \$2,569; amount paid patrons, \$21,290.

Made butter, April and December, 1905. Total pounds of milk, 184,972; total pounds of butter, 8,137; total amount of money, \$1,038; average pounds of milk for a pound of butter, 22.73; average price per pound butter 23 cents; average price per 100 pounds of milk, 91.62 cents; price per ton, \$15,52; cost of making, \$24,411; amount paid to patrons, \$1,041.63.
