CZAR BIDS FOR VOTE

UKASE DISTRIBUTING LANDS HURRIED THROUGH.

Part of Plan Incomplete—Matter of Payment to Be Fixed Later. St. Petersburg, Aug. 28.—The distribution of crown appanages, the first part of the administration's agrarian programme by which it is hoped to win the peasantry to the support of the government at the coming elections was put into effect to-day, when a ukase was published transferring 4,500,000 acres of appanage lands to the Peasants Bank for distribution to the peasants.

Placed In Control.

New York, Aug. 28.—William A. Vanderbilt has been placed in charge of the vast electric railways recently acquired for the New York Central railroad, which form a chain from this city to Buffalo, including the International railway of Buffalo and its adjacent connections.

To Be Court-Martialed.

Quebec, Aug. 28.—It is understood that Capt. Kingsmill will have to face court-martial for the recent accident to H.M.S. Dominion. One story has it that Mrs. Kingsmill was a passenger on the battleship, which is contrary to navy regulations.

Montreal, Aug. 28.—S.S. Salscia, Donaldson line, from Glasgow, is due at Father Point, Que., 2.25 a.m.; has a few passengers on board.
