COMPANY IS FORMED

TO MANUFACTURE BRICK ON THE RIDEAU.

Peculiar Clay Belt From Kingston Mills to Jones' Falls—The New Brick Will Be Better and Much Cheaper Than That Now in Use.

The company which A. M. Chisholm has organized for the manufacture of brick is to be called the Perfect Brick and Tile company, with capital of \$50,000. All the stock has been taken by Ottawa and Kingston gentlemen.

Next week, Mr. Chisholm will go up the Rideau to Washburn to make preliminary arrangements for the erection of buildings and wharves at various places between there and Jones' Falls. The company has secured the right to canal from Kingston Mills to Jones' Falls for manufacturing bricks. This clay is of unusual composition, and makes the finest brick yet offered for sale. There is only one other belt of clay like it, and that is in Indiana.

Mr. Chisholm has a number of the bricks made from the Rideau canal clay, and they are certainly far ahead of anything yet seen here. They can be burned to any color, and are pronounced as much more durable than the brick at present in use.

Mr. Chisholm says that these bricks can be manufactured far cheaper than those on the market now. His company expects to sell them for ten dollars a thousand, or about half the cost of others. Already several builders in Ottawa, have contracted for two million and a half of the new bricks, and the company could have had orders for six millions, but wish to start slowly. About 100,000 a day can be manufactured when the plant is in operation.

Rights to the clay belt in question have been in possession of two Kingston men in some years, but nothing was done in the way of utilizing them. They knew of the clay's properties, and the uses to which it could be put. Lately, Mr. Chisholm was interested, and undertook to form a company and have the manufacture begun in the spring.
