## COMMERCIAL MATTERS.

What is Going On in the Business World.

The big earthquake at Kingston, Jamaica, on June 1st, cast the West Indian Grand Trunk Railway System's railroad bridge from June 2nd to June 1st, 1906, into the sea.

It is said that Wanamakers did a \$16,000,000 business in the past year, and out of their profits they paid for their new building in New York.

The Adams Express Company as to its stockholders in calling in trust bonds to equal to a dividend of about 200 per cent.

The earnings of the Montreal Street Railway made a new high record on Saturday, and for the first time in the history of the company, exceeded the \$13,000. The total earnings were \$13,100.

It is understood that the Greenway management is contemplating still further increase in smelting capacity beyond the present eight furnaces, which have a capacity of 1,200,000 pounds of copper per annum.

Over half a hundred logging camps on the coast having a total output of 33,250,000 feet of logs, will be thrown out of employment.

Has Made Complaint.

Salem, Ore., June 20.—Formal complaint has been drafted, and is ready for signature, and forwarding to the Interstate Commission, by the Oregon railroad commission, against a number of railroads including the Washington and Canadian Pacific declaring the present rate on denatured alcohol unjust and unreasonable.

(1) That the general synod be requested to subscribe the work of the Sunday school of the church in such way as may be arranged through the Sunday school committee of the general synod.

(2) That the stipend and expenses of the secretary be provided by a proportionate assessment on all dioceses affected.

Mr. Bedford-Jones referred to the schemes for the instruction of the children. He had in his Sunday school what he considered to be one of the best schemes, yet it was not satisfactory. The public schools would not tolerate such a number of schools but would arrange at some system to govern a traveling secretary for the Sunday school work.

The debate on this motion was continued when the synod resumed at three o'clock this afternoon.

The notice of motion of Rev. T. J. O'Connor-Fenton, B.A., regarding certain grants to priests in mission fields, has been laid over until the next session of synod.

Before adjournment, on motion of Rev. C. C. French, a heating scheme was tendered to the judges of the competition, who have to kindly entertain the synod.

Six delegates were appointed to attend the Pan-American conference, to be held in London, England, in June, 1908. The delegates are Rural Dean Dibb, Rev. H. H. Bedford-Jones, the chancellor and Messrs. R. V. Rogers and E. J. Penso.

## NONE FROM THE 14TH

## WILL JOIN THE COMPOSITE CITY REGIMENT.

To Go Into Camp—The Men Cannot Afford to Lose Part of a Week at the Rate of Pay That is Offered.

In connection with the June military camp, endeavors have been made for the past two years to get composite city regiments to go under command for three days, but the experiment in Eastern Ontario has not been a success. Two companies from each of the towns of Kingston, 15th of Bellville, and 57th of Peterboro, have again been selected this year to make up a composite regiment for Barriefield camp, but as yet it is doubtful if half a regiment will be recruited. The 14th of Kingston will not contribute to the strength. Efforts to get eighty-four men to go into camp have failed. Peterboro may secure the number though it is doubtful. Belleville being a rural constituency, ought to toe the mark.

Why is it impossible in Kingston to secure two regiments for the camp?

In the first place, the 14th Regiment has three months of drill every year, and the men do not feel the need of any more manoeuvres. They are but volunteers, and not paid for loss of time. At camp the rural regiments receive the only drill given them, and this time of year the ruralists do not mind going into camp.
