## PASSAGE U. S. WARSHIPS

### The Correspondence Tabled in the House of Commons This Week.

#### From Our Own Correspondent.

Ottawa, April 9.—For days there has been little doing in the Commons. Private bills have run their course, and public business will monopolize the attention of the members. The civil service report has been printed, and there have been other matters incidental to legislation which are interesting.

For instance the official correspondence relating to the passing of United States warships for the great lakes through Canadian canals has been tabled. The record shows that permission was given on June 28th, 1897, to pass the schooner rigged warship San Juan de Austria, designated for the use of the naval reserve of the state of Michigan.

The United States gunboat Sandvial, by order-in-council on August 1st, 1907, permitted passage through the Canadian canals to Charlotte, N.Y., where she was to be stationed for instructional purposes, to replace the Frodo.

After a year and a half in the hospital at Kenora, Michael Brudenek walked out, the bone of the leg, which had been shattered, having completely healed.

## ROMANTIC DAIRYMAIDS

### Law to Penalize Them for Putting Love Notes in Cheese.

Ottawa, April 9.—In Hon. Mr. Fisher's bill to amend the inspection and sale act, now before parliament, the minister of agriculture has taken measures to put an end to the cheese box romances, which have attracted attention in the old country. It has been found that glass bottles occasionally slipped into the centre of cheese, by romantic Canadian dairy maids, and the receipt of patriots and other proposals, full as full, into the hands of romantic purchasers, who, after breaking the bottles in cutting the cheese, are more apt to grumble about the in convenience and nuisance than they are to take any serious interest in the contents of the dairymaid's note.

The bill which Mr. Fisher has introduced will declare it an offence to put any foreign substance whatever into cheese, or to incorporate any inferior cheese or cheese therein. The penalties provided under the act will apply against anyone who either manufactures or deals in these inferior products.

#### MATTER ARRANGED

And Railway Will Not Go Into Receiver's Hands.  
New York, April 9.—Danger of an Erie railway receivership, on account of the \$5,500,000 notes which matured yesterday, and other floating indebtedness of the company, was removed at the eleventh hour by a new and unexpected development. The management of the company and J. P. Morgan & Co., its fiscal agents, had offered to give new six per cent three-year notes in exchange for those maturing yesterday, the exchange of these notes being made a condition by proceeding to a loan of \$5,000,000 by a syndicate headed by J. P. Morgan & Co. Instead of this, however, arrangements were made less than an hour before the close of the stock market for payment of maturing notes in cash and the furnishing of the \$5,000,000 additional capital as well.

\$7,682 Cash in Wall.  
New York, April 9.—Lacking faith in banks as depositories for his savings, William H. Wilkins, of Whitestone, L.I., who died recently, devised a unique arrangement for the safe keeping of his money.

His daughter found \$7,682 in gold and silver coin, stored away in a hole in the wall. She said her father caused a sort of repository to be built in the wall of the kitchen. After it was once sealed up he had no way of opening his home made bank and he dropped money through a slot from time to time. From the day he had the place built up to the time of his death he never disturbed his hole in the wall savings.

To Soon Pay Pensions.  
Melbourne, April 9.—Premier Deakin is devising a scheme whereby old age pensions of ten shillings weekly shall begin in July, 1909. The laborers propose that the money should be secured by an appropriation under the customs revenue bill, now before the house of representatives.

PASSED THE HOUSE.  
Washington, April 9.—By unanimous vote the house committee on the judiciary, yesterday, agreed to report favorably the "paper trust" resolutions, introduced by Speaker Cannon. One of these resolutions directs the attorney-general to inform the house what steps have been taken to investigate and prosecute the International Paper company of New York, and other corporations or combinations engaged in the manufacture of pulp wood or print paper. The other resolutions direct the secretary of commerce and labor to inform the house of what steps have been taken by the bureau of corporations towards investigating the alleged "paper trust." The resolutions subsequently were called up in the house and passed.

TWO THINGS IN VIEW.  
To Receive Fleet and to Quit Public Life.  
Several circumstances have combined of late to focus public attention upon U. S. Secretary of the Navy Victor Howard Metcalf. One of these is his trip across the continent to officially welcome Admiral Evans and his great fleet upon arrival at San Francisco. Another is Secretary Metcalf's announcement that he will, at the end of the present administration retire from public life and resume the practice of law. Many persons, however, predict that his retirement will be but temporary and that he will ere long be United States senator from California. Mr. Metcalf is a native of Utah, N.Y., and a graduate from Yale College. He practiced law for a couple of years in his home town and then, about 1880, when he was twenty-seven years of age, moved to Oakland, Cal., and opened a law office. He served several terms in congress and was secretary of the department of commerce and labor before President Roosevelt gave him the navy portfolio.

Personator Fined \$500.  
Montreal, April 9.—George Poits whose name has been called in the recorder's court so many times, and who finally appeared before Recorder Dupuis, about ten days ago, and pleaded guilty to the charge of personating, appeared, yesterday, and was sentenced to one hour's imprisonment and a fine of \$500, or six months in jail. Poits was arrested while trying to personate Isaac McLean in St. Baptiste ward, at poll No. 1 in the recent civic election. The fine was paid.

Gets \$20,000 For A Leg.  
New York, April 9.—The first judgment under the labor law passed by the legislature in May, 1906, making railway companies responsible for injuries received by an employee through the negligence of another employee, has been awarded in the supreme court John Toner getting a verdict for \$20,000 for the loss of his left leg in July, 1906.

Bonus Of Railway.  
Brookville, April 9.—A meeting of the electors of the township of Bastard and Burgess South was held in the town hall, Portland, on Tuesday, when the matter of a bonus to the Ottawa-Bingston railway was considered, but no definite action was taken until a subsequent meeting is held in conjunction with the township council.

## BLOWN TO PIECES

### An Explosion of Natural Gas in a Brantford Building.

### An Employee Was at Work and When He Struck a Light the Explosion Occurred --House Was Vacant.

Brantford, Ont., April 9.—A five-story and a half residence, belonging to George Bickell, and situated on 93 Murray street, was totally wrecked yesterday, as a result of an explosion of natural gas, which practically blew the house to pieces. The gas connections had not been made since Saturday, and an electrician named Thomas was busy installing electric lights. In the upper story he lit a torch to solder some iron, and immediately as he did the gas went off with a cannon-like report. He was standing between two open windows, which was all that saved him from being badly burned.

The leak was found under the floor of the first story, and the house was fairly filled with gas. The front window downstairs was blown clear across the street, and the walls of the foundation shattered. Every room was a wreck, so great was the force of the explosion. The damage will amount to over \$1,000. The house at the time was unoccupied, and was being made ready for occupancy by Thomas Foulger, a retail clerk, said to be contemplating matrimony. The firemen from both departments were called out, but there was no blaze to amount to anything. The explosion is the second one of its kind resulting from natural gas in this city during the past few weeks.
