ASKS A SQUARE DEAL

GOVERNMENT HAS TRIED TO SERVE THE PEOPLE.

Nothing in the Way of Advancement Suggested in the Opening Meeting of the Government Campaign.

Hamilton, May 5.—To use a time-honored phrase Premier Whitney fired the first gun in his campaign here to-night. It may be added that the powder was a little damp. The main meeting was held in the Savoy theatre, and in anticipation of a great crush arrangements were made for the holding of an overflow meeting at the conservative headquarters, which was to be addressed by Hon. W. J. Hanna. The overflow meeting was held, but shortly for it was not so great as had been anticipated, including the band of stalwarts who sat behind the premier on the platform, there were some 1,000 people in the theatre. Amongst them was an unusually large percentage of ladies. As Mr. Whitney's speech proceeded it was evident from the demeanor of a part of the audience that they were somewhat disappointed at his failure to present a constructive programme.

Mr. Whitney, as he had previously indicated, attempted no defence of the government of the Canadian North-western lands. To use his own words he boasted of what his government had done, and claimed that the people would enforce it. So far as the assemblage he addressed was concerned his opinion was expressed by the eloquent silence in which it received the premier's statements.

With regard to the La Rose grant Mr. Whitney claimed that the government had only acted honestly. The La Rose people had undertaken to procure the necessary evidence to upset the claim of O'Brien. It was understood, said the premier, that they would not undertake that work at their own expense. "There was no bargain," but there was the feeling there should be between two honest men.

Mr. Whitney spoke for an hour and three-quarters. He dealt at length with the finances of the province, claiming that the revenues had been increased by developing the assets of the province and the more careful collection of revenue. The increased expenditures, he declared, on the ground that they had been made in the interest of the people. "As a matter of fact he claimed that the money had been paid back to the people instead of being allowed to accumulate in the treasury."

The government, he contended, had carried out all its election promises except with regard to law reform and the foundation for that had been laid. With regard to cheap power the government was in a position which could not be criticized. It was to the credit of his administration that the liquor laws had been strictly enforced while the three-fifths clause had brought about such good results that it was not wise to make any change. Mr. Whitney also took credit to himself that he had brought down a more general redistribution scheme. Throughout his speech the premier made no announcement as to future policy.

The members of the cabinet accompanying Premier Whitney were Hon. J. J. Foy, N. J. Hanna, R. A. Pynn, N. Monteth, Frank Cochrane and J. S. Hendrie.

In Japan these vegetables grow to a weight of thirty pounds, and favor of the sakurajima, is peculiar to that of our own radish, but it is more delicate. The flesh is far superior to that of the native product, being like an apple in color and texture. The sakurajima can be sliced and keeps well. A single small radish will be sufficient to furnish a meal for an average family. The particular advantage of this product is in the fact that it may be eaten at any time after the vegetable has properly fermented until it has fully matured.
