IS A FORGER

In Addition to Being a Bigamist

HAD FIFTY COPIED

THE SIGNATURE WAS A GOOD IMITATION.

Anderson, Bigamist, a Real Bad Man—He Forged Certificates Stating That He Was a Graduate of Queen's—George Y. Chown Receives the Forged Paper.

J. E. Anderson, the bigamist, who married the twenty-one-year-old daughter of Rev. W. S. Jamieson, of Kenilworth, and who now is in the penitentiary here, is a forger as well. It will be remembered that Anderson claimed to be a Queen's University graduate. This was denied by Registrar George Y. Chown, who could find no entry of Anderson's name upon the university books. Yesterday Mr. Chown found out Anderson's deception. The information came from the secretary of the Brockville Board of Education, who sent Mr. Chown a certificate handed in by Anderson two months ago.

This certificate bore the signature of Mr. Chown, perfectly forged. It stated that Anderson had graduated at Queen's in the year 1894, and had secured second class honors in mathematics and physics. It also stated that Mr. Anderson had specialist standing in those subjects. The certificate was dated April 15, 1898, and was made out after the Ontario educational department had inquired as to Anderson's professional standing. It not being satisfied, Anderson immediately set to work and made out his own certificate, and he certainly executed them well. Mr. Chown was surprised at the fine imitation of his signature.

It would seem that Anderson didn't receive any too heavy a punishment in being sentenced to seven years in prison. When he arrived, on Saturday, some of the penitentiary officials remarked that he was a criminal shaped jaw. The forgers bear out the correctness of their reading of the bigamist.

BRIBERY CASES GALORE.

The Liberals Are Preparing For a Protest.

About seventy-five liberal workers met in the Golden Lion committee rooms, last evening, to report upon cases of bribery by the conservatives in Monday's election. At least an hundred cases were reported, and names and particulars given. Prominent conservative workers are involved. There are some cases of intimidation also on the docket that will make interesting reading when the principals are under examination. The bribery was widespread, and probably not half of it will ever be known. However, the liberals have enough evidence on hand to unseat Mr. Nettle and to make things warm for some of his active supporters. Kingston will again be in the limelight for political corruption. The liberals' sole object is to show that the conservative party here is just as corrupt as it was in the old days when Sir John A. Macdonald was unseated for bribery on the part of his most enthusiastic workers. The bribery cases will be carefully enquired into, and the evidence got into shape for a protest petition. The matter is in the hands of the liberal executive and a further committee of the active workers.

Five hundred people attended the "At Home" held in the city hall, Tuesday evening, under the auspices of the Canadian Order of Chosen Friends, and the affair proved a very pleasant one. A young man who was sitting in the park reading heard the child cry out and immediately hurried to her aid. When the little girl was finally got back on dry ground she was so frightened she could hardly speak and would not tell her name. This makes three or four children that have fallen in the water at this spot this year. The high water makes it very dangerous for any small children playing around and the parents should keep them away from the waterfront.

Want A Longer Period.

The Kingston Milling company will not accept a ten-year franchise of the streets for carrying wires to their mill for the transmission of power from Kingston Mills waters. The company asks the city council to grant it a franchise covering the same period granted by the Dominion government for the use of the water power, viz. twenty-five years.

With \$26,000 of strike money distributed throughout the city, there should be prosperity here during the summer.

POST OFFICE DANGER.

Loose Coping Stones May Cause Loss of Life.

The coping under the roof eaves of the post-office building is in a dangerous condition. On Monday night one large stone fell, and smashed an iron grate beneath. Had there been any person on the spot identification of the remains would have been impossible. Other of the coping stones weighing 30 pounds each are becoming loose, and a couple are liable to fall at any time. Postmen fear to come out of the back entrance and are getting out through the large window instead. There should be no delay in making repairs. The local government architect should go ahead at once and have the stone coping rendered safe, or lives will be in danger if a stone on the street side falls. The public works department should give its architects power to go ahead with things of this kind, and not require reports, for there are such distressing and sometimes dangerous delays. The postmaster has reported the matter to the department.

MADE FOOLS OF THEM.

What Happened to Two Drunks in City Park.

Last evening two young men, badly intoxicated, went out to the city park to sleep off their jag. They managed to get to the centre of the park and stretch out under a tree, and were soon "dead to the world." After the hand had left the cricket field and the people were going home the two drunks became the prey of some fellows out looking for fun or trouble, and five minutes after they discovered the sleepers they could not be recognized. The coats were taken off, turned inside out and put on the wrong persons, and their trousers were turned inside out. One man's face was blacked with matches and the other had a handkerchief tied around his forehead, making his hair stand up on end. How the men became entangled or got out of the park is not known as they were still enjoying their well earned sleep when the watchers left them.

New York, June 10.—George Gould, who has sailed for Europe, is quoted as having said: "I expect to attend the wedding of my sister, Madame Anna Gould, to Prince Boris de Saxe. The marriage is to take place with my consent and blessing and with the full consent of all the Gould family."

ARE FOR CORTELYOU

AS CANDIDATE FOR THE VICE-PRESIDENCY.

Open Exchanges on Candidacy Thus Far Prevented by the Presidential Aspirations of Governor Hughes.

Washington, June 10.—Indications are multiplying that Secretary Cortelyou will be advanced by the Roosevelt and Taft forces at Chicago as their candidate for vice-president. Secretary Cortelyou himself naturally declines to discuss the matter of his candidacy for the very sufficient reason that his native state already has in the field a possible candidate for the presidency in the person of Governor Hughes.

One reason for their confidence is asserted to be their belief that by the strenuous opposition offered by the Fairbanks contingent to the recognition of southern Taft delegates in the battle before the national committee now in progress, the couplings of the names of Taft and Fairbanks or of Roosevelt and Fairbanks on one ticket has become impossible.

It has been determined by the friends of Governor Curtis Guild, of Massachusetts that his name shall be presented to the Chicago convention as a candidate for vice-president.

Headquarters For Hammond.

Chicago, June 10.—The first headquarters for a vice-presidential candidate were opened, Tuesday, at the Auditorium annex for John Hays Hammond, of New York. They were in charge of John C. Montgomery, of New York. Mr. Montgomery declared that Mr. Hammond will arrive in Chicago late this week, or on Monday.

According to the closest possible calculation based upon figures conceded by the allies Secretary Taft will receive on the vote 55 votes, or sixty more than enough to give him the nomination, providing the convention does not take the matter in hand and override the decisions now being made in contested cases.
