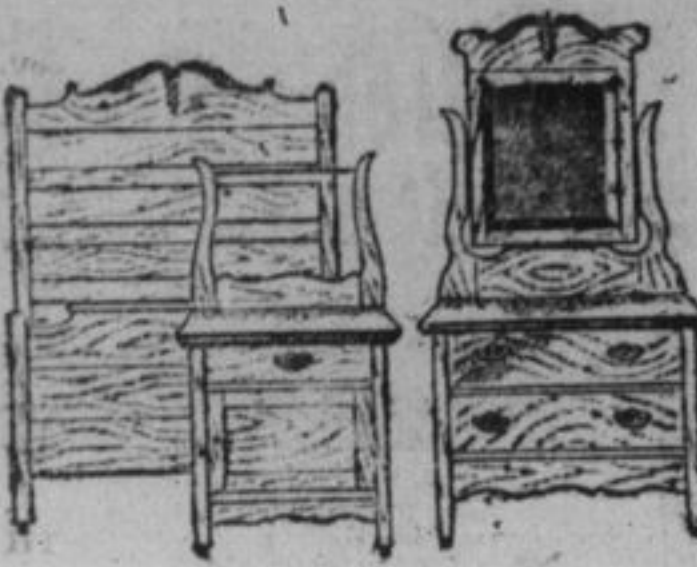

Both bartenders, on oath, had sworn that they took Redden to be of age, and he himself, on looking at him, might pass him as being twenty-one years of age.
