TO STOP BIG FIGHT

ORDERS ARE ISSUED BY GOVERNOR GILLET.

California's Executive Takes Steps to Prevent Meeting Between Jeffries and Johnson in San Francisco on July 4.

San Francisco, June 15.—Stirred to action by protests from all parts of the state and country, Governor James N. Gillett, to-day, took steps to prevent the championship fight between James J. Jeffries and "Jack" Johnson, scheduled to be held in San Francisco on July 4th.

In a letter to Attorney-General U. S. Webb, the governor, to-day, expressed his disapproval of prize fighting and directed that the courts be invoked to prevent the match.

The letter declares that the supreme court of California has never defined a prize fight, and suggests that an opportunity be given it to do so.

While the status of the fight is unsettled to-night, the sporting fraternity is much cast down, and it is generally believed that the death knell of prize fighting in California has been sounded.

This belief is borne out by the fact that the governor telegraphed to Attorney-General Webb later in the day to take similar action as to the fight scheduled for June 18th, in San Francisco, between Sam Langford and Al Kaufman.

Promoters Tex Rickard and John Gleason had heard no whisper of the governor's intended action.

After a conference with Webb, Rickard said he believed that the fight would be held in San Francisco on the advertised date, despite the governor's orders.

Rickard would not say what his course would be until Webb handed down an opinion, but he has no intention of abandoning the effort to hold the fight here.
