To Walter A. Telfer Against R. G. Dun & Company.

A SEDUCTION ACTION

RESULTED IN AWARD OF \$800 TO GIRL'S FATHER.

A Gananogue Alimony Case Was Heard, but the Judge Reserved Judgment—A Slander Case Was Settled Out of Court.

R. G. Dun & Company, Toronto, must pay Walter A. Telfer, proprietor of the British American hotel, the sum of \$1,000 for publishing in its Bulletin of 2nd February, 1911, that the above hotel was in charge of a buildiff, which was absolutely false.

It is reported that the company will appeal the case. When the case was resumed Wednesday afternoon, Henry Kelly, district manager for R. G. Dun & Co., was called and told of having been informed at the head office in Toronto, that the item concerning Mr. Telfer was incorrect.

The evidence of the previous witness, closed the case for the defendants, and then Mr. Hutchinson re-called Mr. Telfer concerning some previous evidence.

In his address to the jury, Mr. Cowan stated that it was a case of a most regrettable nature. He had no intention of offering any excuse for the error but wished to point out that this was an accident, and to use an old phrase, "accidents will happen even on the best regulated families."

The company regretted very much the publication of the item. Continuing, Mr. Cowan referred to the mortgages taken by Mr. Telfer on his hotel furnishings and stated that if the hotel was doing a good business, it would not be necessary for Mr. Telfer to put a chattel mortgage for the sum of \$7,500 as he did.

Plaintiff's daughter, Frances Offord, aged 18 years, when sworn to by Mr. Whiting, told of her relations with Mr. Telfer, aged 34 years, since they became acquainted in February, in July, 1910. The Offord family is now living in Gananogue. The plaintiff was also questioned by Mr. Whiting.

Mr. Whiting, in addressing the jury, said its only duty was to fix the rate of damages. The plaintiff had suffered considerable financial loss, but most of all should be compensated for the shame and degradation brought upon his home, and the blot it has placed on his daughter's life.

His Lordship, in summing up, said the law was perfectly clear, and, that the jury, when assessing the amount of damages, should make an example of this man.

After being cloistered for thirty minutes the jury brought in a verdict awarding plaintiff \$800 damages.

The case, Nicholas Ward vs. Daniel Graves, action to recover \$1,000 damages for slander, had been settled out of court. The defendant had apologized. Herrington, Warner and Grange, Napanea, appeared for plaintiff, and Macdonnell and Farrell for defendant. This ended the jury list.

On the non-jury list case, Johanna Goodfriend vs. John P. Goodfriend, occupied the attention of the court till 6:30 o'clock. Hutchinson and Fisher, Brockville, appeared for the plaintiff and J. A. Jackson, Gananogue, with J. L. Whiting, Kingston, represented the defendant.

Plaintiff, when sworn, to Mr. Hutchinson, told of her marriage to defendant, and of in May, 1909, of her husband suffering a paralytic stroke which left him in a helpless condition, physically and mentally.

Plaintiff said she and her husband were living on a fifteen-acre farm on Howe island at the time. For eighteen months after her husband's illness she struggled on with hired help, when she could get it, at the work of the farm. But it soon began to take its toll on her health.

The plaintiff stated further that she received word several times that her husband's relatives were going to bring him to Gananogue, but never did. In January she went to her father-in-law's house, and her sister-in-law told her husband not to return with her. She made repeated visits to her husband's house up to September last. On two occasions her husband's sister had locked the door on her and the last time had shoved her out of the kitchen.

stress had been put on the fact that Mr. Telfer had taken out two chattel mortgages, but no evidence was given to show that this information had been published in the Bulletin. It was held that the hotel business credit had to be relied upon, and Mr. Telfer was not in a position to put his finger on the amount of damage he had sustained.

As an hotel-keeper, Mr. Telfer had to secure credit, otherwise he could not run the hotel. It was impossible to get a net after all who had stopped staying at the hotel, but it had been proven that business had shown a falling off. Mr. Telfer's books had been produced, and it was shown that there had been a falling off of about \$11,000.

Mr. Telfer suffered as a result of the report, and the guilty party should be made to pay. Counsel for defendants claimed that Mr. Telfer had not shown damage, amounting to \$100. Was the loss of about \$11,000 all a mistake? When a company made such blunders, they should be made to pay and a lesson should be given the company that they must have reliable agents.

The man who had sent the information had not been called, the defence taking as their stand in this action, that he would have to divulge the source of his information, and thus before the high court all Wednesday. After being out an hour and a half, the jury brought in its verdict, finding for the plaintiff with costs.

The verdict was of a more or less peculiar nature, stating that the jury did not feel that Mr. Telfer's loss had been severe, but recommended exemplary damages to the extent of \$1,000, as Dun & Co. had certainly been negligent in not properly investigating before publishing what they did regard Mr. Telfer's credit.

Mr. Whiting questioned plaintiff very minutely, dealing item by item with the sale of the farm stock. The \$375 which she retained after her husband's debts and the running of the farm were paid, had been all absorbed in her boarding house venture in Gananogue.

Mr. Whiting urged that plaintiff should leave her husband with his people, where he is slowly improving he having only \$140 per annum, the rent of the farm, to live upon. The husband is willing to give one-third of his yearly income to his wife, and is willing when he recovers sufficiently to return with his wife to the farm.

A number of witnesses were present to corroborate the plaintiff's evidence, but were not called upon. His lordship reviewed the case with the counsel and will give judgment later.

THE CAR OF THE FUTURE. What Henry Ford Sees Ten Years From Now. The automobile of to-day doesn't need much tinkering with, according to Henry Ford, whose phenomenal success in the automobile manufacturing business certainly entitles his opinion to the greatest respect.

"The automobile has been pretty well perfected," said Mr. Ford, the other day. From now on there will be very little change in the motor car, except little refinements. In my opinion, the light cars will be found in far greater numbers than they are now.

"There's no use in trying to get efficiency out of a heavy automobile. Heavy cars are made for luxury, and not for efficiency. Now, while the sales of the Ford for example, will reach 75,000 in 1912, I am positive that one of the chief reasons of this big distribution is in the light weight of the Ford. The fact that we reduced the price this year twelve per cent., bringing the completely equipped Touring Car down to \$850, was not the real reason why the sales increased so tremendously.

The real reason for the success of the car lies in the fact that people know that the car will be cheap to maintain after they get it, primarily because of its light weight. The trend is toward the light car and the use of the very finest materials like Vanadium steel."
