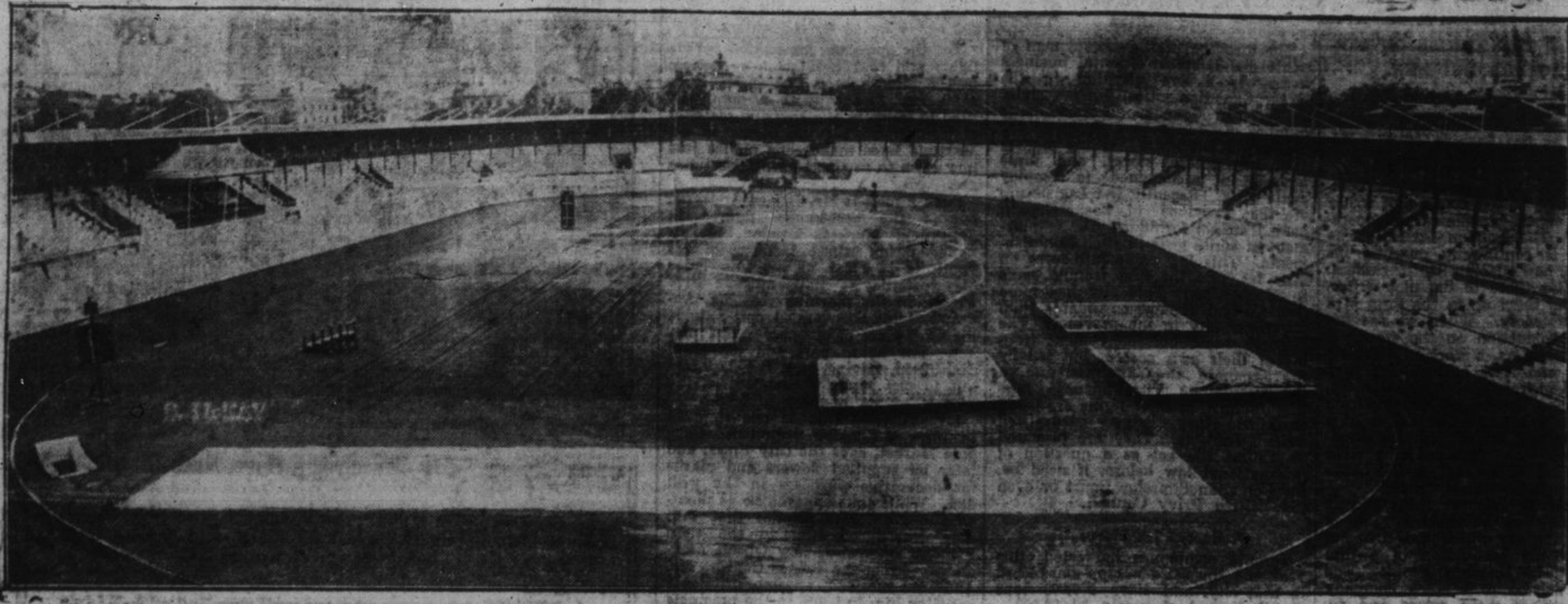


# SCENE OF THE GREAT OLYMPIAD AT STOCKHOLM, SWEDEN
