





Kenneth McIver, of Dumfriesshire, said that schools here impressed him as being more practical in their methods, but less thorough. The buildings, he said, were generally superior to those in Scotland, but speaking generally, he believed that Canada's system was inferior.

GONE UP THREE POINTS.

Canadian Locomotive Stock is Considered Good.

The financial editor of the Toronto News writes:

"When Locomotive Common sold at 45 it indicated a gain of three points over the next preceding sale. More was in demand at that figure but holders were not anxious to go into the market."

"No industries in Canada are in a more prosperous condition than are those devoted to the production of railway equipment."

"All the leading roads on both sides of the line are badly in need of cars and locomotives."

"Notably is this the case in Canada and so long as the country continues to expand as it is doing at present so long will the resources of such companies as the Canada Locomotive and the Canadian Car be taxed to the utmost."

"There are every signs that the locomotive works at Kingston will be running under high pressure for the next three years at least, and that even when the present plant has been doubled as will be the case next year."

"Ever since A. W. Wheatley took

charge as manager last year marked progress has been made. Coincident with the introduction of various economies in administration steps were taken to increase the capacity of the company's plant from 6 to 16 locomotives a month."

"Already the results of this policy have been made apparent—the earning being largely increased without any great addition to the fixed charges—as it is expected, will be fully shown at the annual meeting in September."

FOR DISORDERLY CONDUCT

Another Youth Was Fined in the Police Court.

The police are continuing their campaign to stamp out disorderly conduct on the street. In police court, on Thursday morning, Magistrate Farrell fined a youth \$3 and costs for being disorderly on the street. He pleaded guilty to the charge.

Another youth charged with a similar offence, pleaded "not guilty." He claimed that "the other fellow" started in to fight him, and that he had just defended himself. "He was doing the fighting," he remarked to the court.

"And what about you?" asked the court of "the other fellow."

"Well, he aggravated me by following me up the street."

A man who was never in the police court in his life, made his bow before the magistrate. He is a member of the "prohibited list," but lost his grip on the "water wagon." He pleaded guilty to being drunk, and told his story. He said he had been in Gananoque, and secured part of the liquor there. The remainder he found, and he proceeded to tell the court how it all happened. In the barn, where he had been working, he pulled away a pile of hay, and he found a flask of whiskey, and he could not resist the temptation.

Sales Made at Frontenac Cheese Board on Thursday Afternoon.

Cheese sold at 12 15-16c. on the Frontenac cheese board at the Thursday afternoon session, but only three factories sold at that price, the salesmen looking for a higher price. There was boarded 35 boxes of white cheese and 630 boxes of colored, as follows: White-McGrath's, 35.

The board of license commissioners met, on Wednesday afternoon, in the office of Inspector C. W. Wright, and granted transfer of liquor license from C. D. Horne to Lewis Martin, and also from J. S. Randolph to John Cousineau. In the first removal of license will be granted from the Provincial to the Royal hotel, and in the second, from the Randolph to the Grimason hotel. It will be remembered that the present proprietor of the Randolph, James Spence, had his license removed at a former meeting, from the Hall hotel to the Randolph.

SHOULD BE FRIENDLY

JUDGE PRICE GAVE GOOD ADVICE FOR NEIGHBORS.

James Thompson, Kenner Township, Pleaded Guilty to Serious Charge, But Was Allowed to go on Suspended Sentence—Accused Did Not Realize Seriousness of Act.

Neighbors should be friendly and help one another. They should not be trying to stir up trouble.

Thus spoke Judge Price, in chambers, at the court house. Thursday morning, after hearing a case in which two Kenner township men, James Thompson and D. F. Detor, were involved.

Detor laid a very grave charge against Thompson, which read as follows:

"That he did unlawfully threaten to accuse B. F. Detor of an offence punishable with imprisonment for more than seven years, namely arson, with the intention of compelling the said B. F. Detor, from collecting a certain account from him for \$50."

Crown Attorney F. A. L. Whiting appeared for the prosecution while T. J. Rigney was present on behalf of Thompson. Mr. Rigney first put in a plea of "not guilty" in order to have the accused sworn to give his evidence, and then changed his plea to that of "guilty."

Mr. Rigney pointed out that Thompson would plead guilty to sending a threatening letter, but that he was ignorant of the seriousness of the thing. Thompson told the court that the letter had been written by his wife at his request. He also admitted that there was some trouble over an account. Mr. Rigney pointed out that Thompson had always borne a good character and asked for leniency.

Mr. Detor was present, and the latter figuring in the case was produced and handed to the court. Detor, under oath, swore that Thompson had accused him of was false.

In summing up the case Judge Price said that he believed that ignorance had been the cause of the trouble and he pointed out to Thompson that he should not have sent such a letter. There was great need for "missionary work," as he termed it, among people who would do such a thing as this. Neighbors should be friendly, and try to help one another. Under the circumstances he would allow the accused to go on suspended sentence.
