SHERIFF AND SQUATTER

KILLED IN SHOOTING BATTLE AT LATTER'S HUT.

Three Policemen Wounded—Sleaze of Over an Hour—Posse Attempted to Arrest Man Who Had Squatted on Farm Eighteen Years.

New York, Oct. 25.—Sheriff Paul Stier, of Queens County, was shot and instantly killed and three policemen were wounded this afternoon when the sheriff attempted to execute a warrant of arrest issued for Frank Taff, who for eighteen years has lived as a squatter on the old John D. Locke farm, two hundred yards north-west of the railroad station at Whiteston Landing, Long Island.

Here is a list of the dead and injured: Stier, Paul, sheriff of Queens County, shot in the left lung and instantly killed; Taff, Frank, shot in the head and instantly killed; Fitzgerald, James, police sergeant, Flushing, shot in left leg; Fox, John, patrolman, Flushing, shot in left leg; Durkin, John, patrolman, Flushing, shot in the neck, left hip and back; Kerrigan, John, patrolman, shot in the left leg and back.

Taff was armed with a repeating shotgun and two 22-calibre rifles. His ammunition consisted of 150 shells for use in the shotgun and more than 250 rounds for the small calibre rifles. This shotgun, he held his stronghold on the roof of his hut against the two score policemen who had only their revolvers, which they found ineffective against the surer aim of the insane squatter.

Shot Squatter Dead. After killing the sheriff and wounding one of the policemen who first entered the house with the sheriff, Taff took a defensive stand. The police tried to induce him to surrender. He refused, and they at last were forced to shoot. He returned shot for shot, until the police realized the difficulty of fighting the squatter with revolvers.

Sergeant James Fitzgerald, who several years ago ended his enlistment in the United States Cavalry with the rank of sergeant, and recently won a sharpshooter's medal at the Military Training Camp for members of the police force, at Fort Wadsworth, Staten Island, got a Springfield service rifle from the torpedo boat destroyer Henley, which was anchored in the middle of Long Island Sound, opposite Whiteston Landing. It was with this weapon that he shot Taff dead on the roof of his shanty.

FIGHTS THE SUPPRESSION

OF THE RASPUTIN EXPOSE BY METROPOLITAN MAGAZINE

Russian Monk Charges Petrograd Government Connived With Magazine to Pigeonhole Articles Which Reveal Conspiracy for Separate Peace.

New York, Oct. 25.—Whether certain articles dealing with the alleged influence of Rasputin, the so-called Russian mystic, over the Russian court and written by Illiodor, a Russian monk, and alleged to have been withheld from publication by the Metropolitan Magazine, may be published elsewhere in the object of injunctive proceedings brought by Illiodor against the magazine in the Supreme court here.

The plaintiff asks that the magazine be restrained from interfering with me in the publication of my articles, alleging that after the Metropolitan had agreed to publish them for \$5,000, "it seems now and with the connivance of the Russian government the Metropolitan Magazine refused to publish these articles and is willing to pay me in order to suppress them."

Illiodor, who says he arrived in the United States from Norway in June last, alleged that "the suppression of this information at this time when it may weaken or destroy the Rasputin influence and intrigue may work an incalculable injury to Russia and will defeat the purpose for which I am working and have suffered in prison."

Characterizing Rasputin as "an illiterate and uneducated peasant who is known as a pilgrim possessing certain supernatural gifts," Illiodor describes in his complaint the alleged domination of Rasputin over the Russian court, asserts that Rasputin is strongly pro-German and is "now engaged in a conspiracy to bring about a separate peace with the Russian government," all of which was to have been the basis of his articles.

He alleges that when it became known that the articles were to be published he was promised by the Russian consul-general here, Oustinnoff, and the Arch-bishop Evdokim \$25,000 and a full pardon so that I could return to Russia if I did not publish them, and that later on "pretending to take up the negotiations" Oustinnoff paid him \$1,000.

The Metropolitan, he alleges, claims the articles as its property and will join him from publishing them elsewhere. Illiodor claims they are his through breach of contract.

ACT PROHIBITS THE SALE

BUT DOES NOT TAKE AWAY TASTE FOR STRONG DRINKS.

Montreal Man Who Came Here to Kingston, Fell Into the Hands of the Police—Said Entire Police Force Could Not Arrest Him.

Wanted—A clause in the Ontario Temperance Act which will take away the taste for "strong stuff" from every drinker.

The Ontario Temperance Act prohibits the sale of intoxicating liquor, but it does not prohibit the taste for it. Judging by the cases that come up before Magistrate Farrell from time to time there appears to be a drink or two left in the old town.

Camille Labelle, who hails from Montreal, and came to Kingston on Tuesday, got in a stock of "wet goods" before he left home to do him over his little visit. After hitting it up pretty freely all day he set out to see the sights on Princess street in the evening. He must have been taking Scotch whiskey, for when Constable Leslie Armstrong came across him he was doing a Scotch dance on the sidewalk before quite a few spectators. Some person tipped him off to the fact that a constable was after him, and that if he did not behave he would land in the police station, whereupon he declared that he had purchased his liquor in Montreal, had a perfect right to do so, and further, that he was enjoying himself and that no policeman in fact, the entire force in Kingston could not put him under arrest. However, it was the Scotch from the bottle that was doing all the talking, and when Constable Armstrong took charge of him he made no serious complaint.

Arraigned before the court, the accused admitted drinking, and told the magistrate that he always carried a stock with him for "wet and cold days." Tuesday was a pretty fair day, evidently he took some of the "strong stuff" as a safety first method. The magistrate imposed a fine of \$10 and costs, a total of \$13, and the man from Montreal paid up without a murmur. It certainly costs something to get drunk—that is if you fall into the police net. Labelle showed the court a receipt for the purchase of his liquor in Montreal.

OLD LAW OF SUPPLY AND DEMAND

Our Department of Agriculture's estimate is that we can spare only 100,000,000 bushels during the current crop year if the quantity normally required for our own people, 625,000,000 bushels, is retained. But export shipments for these months past from the United States and Canada have been at the rate of more than 400,000,000 bushels a year. If we keep the 625,000,000 needed here, we must bid against the foreign Governments, and such competition in the market may cause a further advance of prices, which are already high. We recently said that consumption here might be reduced, and the exportable surplus increased, by such an advance, although consumers were still buying freely.

Reports from many wholesale merchants and distributors in New York there are no signs of reduced consumption. The demand for food supplies, they say, is unprecedented. They are overwhelmed by orders, some of which they are forced to reject. Buying is not restrained by the high prices. Our people will continue to keep and use their wheat. The Allies will pay the current price, whatever it is for what they need.

"KING SOLD TO HUNS"

Remarkable Statement of Bulgarian Prisoner Taken at Doiran.

"King Ferdinand has sold himself to the Germans, and he has lost." This was the judgment pronounced on the ruler of Bulgaria by one of his subjects captured in the region of Doiran by the French and now a prisoner.

When informed that the allied general offensive had begun on the Salonika front, that the Russians and Italians had joined the British and French forces and were all marching against the Germans and Bulgarians, the Bulgarian prisoner said:

"This war is being conducted by the German allies at home. All those with good education have been given posts of one kind and another and have not been sent to the front; they should organize opposition to Ferdinand's political schemes."

"We lost a lot of men in Serbia. Our chiefs told us that if we surrendered to them the Serbians would massacre us."

"We believed them. That is why we fought them. Our families have warned us against fighting the Russians. If we do we will be cursed for ever when we go back."

"That has added enormously to the desertions, and made surrender frequent."
