

LATE LIEUT. F. C. MAUND

HIS FAMILY LEARNS HOW HE FELL AT THE SOMME.

Hit by Machine Gun Bullet and Died Instantly—Colonel and Chaplain Speak Highly of the Young Kingston Officer.

Lieut.-Col. J. W. Preston, commanding the 39th Battalion, C.E.F., has written as follows to the family of the late Lieut. F. C. Maund, son of Mr. and Mrs. Charles F. Maund, of Kingston: "Lieut. Maund was one of the officers who came over with the 39th Battalion more than a year ago, and we had all learned to esteem him, not only for his many manly qualities, but for his capability and reliable qualities as an officer. He was never given to doing much talking, and one had to know him some time to appreciate him, but I always found that he could be depended on to carry out efficiently any duty entrusted to him, besides which he possessed a great many admirable personal qualities. He in his knowledge of arms, having just completed a thorough course of training at the Canadian Military School here when he went to the front. "When his name first appeared in the casualty list as having been wounded, I hoped that he had not been seriously hit and that we should have him back with us here in the battalion in the course of a few weeks, but a few days later, to our great sorrow, his name appeared in the list of officers killed in action. His death has no doubt been a severe blow for you and the other members of his family, but I trust you will find some consolation in the fact that he died leaving a splendid record of duty faithfully done, and that he gave his life for a cause so well worth dying for."

H. TREE-TRIMMING QUESTION

MANAGER OF UTILITIES TO CONFER WITH CITY ENGINEER.

Will Endeavor to Reach Working Agreement—Fire and Light Committee to Confer With Commission in Regard to Street Lighting.

The tree trimming injunction issued against the Utilities Commission by the city engineer was discussed at a meeting of the commission Monday afternoon, and General Manager Folger was instructed to make a working agreement with the engineer. The feeling of the commission seemed to be that the trimming of trees, where electric wires were concerned, should be done by its own employees under the supervision of a competent man from the engineer's department. The general manager pointed out that the trimming of trees was necessary if the light plant was to be operated economically and if accidents were to be avoided. Limbs coming in contact with wires caused a decided leakage in the current, followed by interruptions in the service and a waste of coal. There was also the danger of a serious accident. Commissioner Toye reminded the commission that some years ago the city issued an order against tree trimming, and that this order resulted in an accident which cost the corporation \$700. The slaughter of the trees on University avenue came for some discussion. Mayor Richardson said that there was no doubt that the trees had been mutilated. Mr. Folger pointed out that the trees had long been neglected by the city, and that the employees of the light department had found it necessary to give them heroic treatment, although the bloodless surgery was probably more far-reaching than it should have been. He was of the opinion that the commission's tree trimmers should continue their work under the supervision of an employee of the city. The commission was also of the same opinion, and the mayor endorsing the idea, the general manager was instructed to reach a working agreement with the city engineer.

No Increases at Present.

A. J. Murray, who was recently appointed receiver of water rates and placed in charge of the employees of the commission in the street lighting department, wrote stating that he was not in a position at the present time to recommend any increases in salaries. He suggested that nothing be done until he had time to familiarize himself with conditions. Some time ago the fire and light committee wrote the Commission asking for an explanation of the low water pressure at some recent fires. Not receiving a satisfactory reply, it renewed its request in another letter. The general manager was instructed to supply the desired information. The auditor reported that the fire and light committee had paid only \$5,900 on the street lighting bill, there being \$11,319 still due. The committee is desirous of reaching a basis of settlement with the Commission, and the general manager was requested to arrange a conference. When the accounts were being considered, Commissioner Elliott said that where there were contracts with the Commission, everything else being equal, should seek to distribute its patronage. The general manager will consider this suggestion.
