War Service Gratuity

Questions Answered.
T.L.W.—You are not entitled to receive any portion of the war service gratuity, having been discharged prior to November 11th, 1918.
J.B.S.—You are entitled to five months' war service gratuity at \$70 a month. Not having been married until after discharge, your wife receives no allowance under the order-in-council.
Mrs. H.M.—Widows of soldiers who were killed in action, or died while in the service do not receive any allowance under the war service gratuity order. The pension is only allowance made in such cases.
M.L.—As you did not leave Canada, and were discharged before the signing of the armistice, you are not entitled to receive any war service gratuity.

JAPAN DEMANDS ARMS TROUBLE IN SIBERIA

United States Commander Unwilling to Hand Over Equipment.
Vladivostok, Feb. 25.—The Japanese staff here has requested Col. Styer, of the American army, to turn over to the Japanese the arms, horses and equipment of the Cosack troops of Gen. Kalmikoff, who mutinied late in January and then surrendered their arms and horses to the Americans.
A short time ago Major-General Graves, the American commander refused a verbal demand of the Japanese staff that he cease to protect the fifteen hundred revolvers of Kalmikoff's forces, on the ground that Kalmikoff's record was not good, that he represented no authorized authority, and that there was no guaranty that he would not revive the reign of terror in the Usuri-Khabarovsk district which caused protests to be made by Gen. Graves to Gen. Otani, the Japanese commander-in-chief.
The Japanese now claim that the equipment of these Cosack troops belongs to them. Up to this time Gen. Graves has not been inclined to concede this claim without assurance that the men when released will not be the victims of Kalmikoff's vengeance.

The United States is protecting itself also. Forty-eight "alien radicals" were recently deported to Europe. This was done however, not because they were aliens or radicals, but because they had been talking illegally. The United States Immigration Act as amended last year authorizes the Federal Government to deport any alien who advocates law-breaking. This catches Bolsheviks and I.W.O.M.
Canada should keep up with the procession.

A Mine Defaulter Jailed

E. J. Davis, convicted of a breach of the O.T.A. six weeks ago, and sentenced to a fine of \$500 or six months' imprisonment, was on Tuesday apprehended by Police Constables Bateson, Armstrong and Clarke, and in default of payment was handed over to the custody of the jailer. Davis' wife is also an inmate of the jail, being convicted on a similar charge.
