

A MINISTER IS REPROVED

Rev. C. S. Applegath, Port Hope, on Carpet

For Making Some Indiscreet Statements in the Methodist Pulpit.

Toronto, June 3.—A decision has been reached in the case of Rev. C. S. Applegath, of Port Hope Methodist church, who was charged with making certain statements regarded as indiscreet, both in and out of the pulpit. This is the finding of a ministerial committee of five, of which Rev. J. S. L. Wilson, Cobourg, was chairman.

The enquiry was held in Port Hope in the early part of the present week, the charges being made by W. T. R. Preston and F. W. Wilson, editor of the Port Hope Guide. Rev. Mr. Applegath was at one time assistant pastor of Timothy Eaton Memorial church, Toronto.

Reprimand by the chairman of his district is the penalty to be meted out to Mr. Applegath, he is also to be admonished to be more careful in his public and pulpit utterances. His term at Port Hope having ended, he has been transferred to Emerald street church, Hamilton.

It is stated that Mr. Preston has given notice of appeal, several of the charges being adjudged as "minor" by the committee, as "major" ones. The appeal will go to the annual conference.

One of the charges, several of which were not sustained, was that Mr. Applegath referred to our Lord as "a little yellow-skinned Jew." The committee condemned the use of such language, but found that it was used without sacrilegious intent.

Separate School Bill Gets Second Reading

Toronto, June 3.—The Mageau bill to amend the separate school act about which so much controversy has arisen, was given its second reading in the legislature yesterday afternoon by twenty-one votes to thirteen.

Messrs. Raney, Nixon, Rolfo and Mills supported the bill and R. H. Grant, minister of education opposed it. All the Liberals present backed the measure and all the Conservatives against.

WOMEN IN THE VATICAN.

Pope Has Brought Old Servant to Look After Housekeeping.

Rome, June 3.—Pope Pius has ignored the conventions of centuries by installing his old servant, Signora Linda, within the precincts of his apartment, appointing her his housekeeper and wardrobe maid, says the Giornale d'Italia. She has been with the Rattl family for 40 years.

Has Important Hearing.

Philadelphia, June 3.—The result of today's sculling race for the Philadelphia challenge cup will have an important bearing on the Royal Henley regatta, on July 5th. Hilton Belles, Canadian champion, has declared that a defeat today will mean his permanent retirement from competitive rowing. Walter Hoover, United States champion, will not take part in the English classic unless he is victorious today. Belyea weighed 181 pounds when he arrived here three weeks ago, but is now down to 150.

POINCARÉ SETS FORTH THE VIEWS OF FRANCE

As to What is Needed to Make the Hague Conference a Success.

Paris, June 3.—In a memorandum despatched last night to all governments invited to send experts to the Hague conference, Premier Poincaré sets forth the conditions that France considers indispensable to ensure the success of the new conference on Russian affairs. It bears a striking resemblance to a document sent January 31st to prospective participants in the Genoa conference.

GEN. CURRIE IS PLEASED WITH SHOWING OF CADETS

Former Canadian Corps Commander Makes Inspection at the R.M.C.

The annual inspection of the gentlemen cadets of the Royal Military College took place Saturday morning, in spite of the threatening weather, while other exercises, including a gymnastic display are to be staged in the afternoon. There were a number of Kingston friends of the college present for the inspection, besides the members of the board of visitors and superior staff.

At 9 o'clock this morning, the inspection opened with the firing of a feu-de-joie by the cadets in honor of the birthday of His Majesty the King. The battalion of cadets was then inspected by General Sir Arthur W. Currie, G.C.M.G., K.C.B., and the other members of the board, after which a march past was held, the salute being taken by the former Canadian Corps commander, on the steps of the new administration building. The cadets then marched to Barrieffield common, where an interesting tactical scheme was carried out. Upon their return to the college, the cadets were inspected as a squadron of cavalry, in which work they demonstrated their splendid training, as in the other branches of the service. Many of the spectators, who had never witnessed cavalry work before, were greatly impressed by the clever horsemanship displayed and the intricate movements during the inspection.

The recruit class gave an exhibition of their proficiency in artillery drill at 12.15 p.m., and immediately after the members of the senior class demonstrated something of the work of the engineer, which included pontoon building, wiring, demolitions, and other arts of the sapper in the field.

General Currie expressed himself as well pleased with the proficiency attained by the cadets this year, while the other members of the advisory board were equally delighted with the splendid exhibitions of military training, gymnastics and mounted sports staged during the two day visit to the college.

DELORME NOT ENTITLED TO FAVORS SAYS JUDGE

No Longer Priest, Only Layman in Sight of the Law.

Montreal, June 3.—The trial of Adelard Delorme, on the charge of murdering his half-brother, Raoul Delorme, has been set for Friday next. On being arraigned yesterday, the accused attempted to seat himself in the dock but was sternly told by Justice Monet to "stand up straight."

Refusing the request by the defence for delay, the judge said accused was being considered as a layman, not as a priest, and was not entitled to more consideration than any other prisoner.

Suffered a Stroke.

Berlin, June 3.—Private advices from Soviet circles here state that Premier Lenin suffered a stroke Thursday. The Soviet leaders left here immediately for Moscow.

MORE FORCES FOR BELFAST

Two Destroyers And 12 Aeroplanes Arrive.

Ulster Premier Pleased With the Results of Conference in London.

Belfast, June 3.—British forces in northern Ireland were reinforced this morning by the arrival of twelve officers and ninety-seven men of other ranks of the Royal Air Force. They are being followed by twelve fighting planes, which are due this morning. Several troops are being sent to the harbor this morning.

London, June 3.—The arrival of two British destroyers at Belfast is reported in a despatch to the Central News.

Ulster Premier Pleased.

Belfast, June 3.—Sir James Craig, Ulster premier, on his arrival from London, told newspapers that he was quite pleased with the results so far as northern Ireland was concerned.

The Refugee Problem.

London, June 3.—The influx of refugees from Ireland is becoming a serious problem in England. Protestant refugees from the south of Ireland are claiming compensation for loss of life, liberty, damage and expropriation suffered. Falling satisfaction from the British government these refugees, with influential backing, propose a petition of right to the Crown.

Wants Minimum Wage For Practising Physician

Atlantic City, N. J., June 3.—A "minimum wage" for physicians—in effect—based on scientific calculation, was advocated by Dr. Henry V. Walls of Pittsburgh, Pa., in an address on the subject "For Services Rendered," before the 11th annual convention of the Allied Medical Associations of America.

Paris, June 3.—Georges Carpentier, champion light-heavyweight pugilist, is to make his theatrical debut soon, says L'Auto, in a romance of the ring, written by Yves Mirande, who wrote "Peg O' My Heart."

Trammen Re-elected Officers.

Toronto, June 3.—After three days balloting the Brotherhood of Railway Trammen in convention here, have reaffirmed the appointment of the former staff of officers. At yesterday's session, Val Fitzpatrick, Columbus, Ohio, and M. J. Murphy, Cleveland, were re-elected vice-presidents.

S.S. Montcalm Ashore.

Three Rivers, Que., June 3.—The C.P.R. passenger steamer Montcalm which went ashore at Becharof, yesterday afternoon, is still aground this morning but is in no immediate danger although in a serious position because the bed of the river is full of rocks. No passengers have left the ship.

Business Is Improving.

Winnipeg, June 3.—"Improvement in business conditions still maintained," "steady to fair," "gradually improving." These advices received are quoted in the weekly report of the Canadian Credit Men's Trust Association. In Montreal, Toronto and Quebec business is reported improving.

Midvale, Republic and Inland Now Unified as North American.

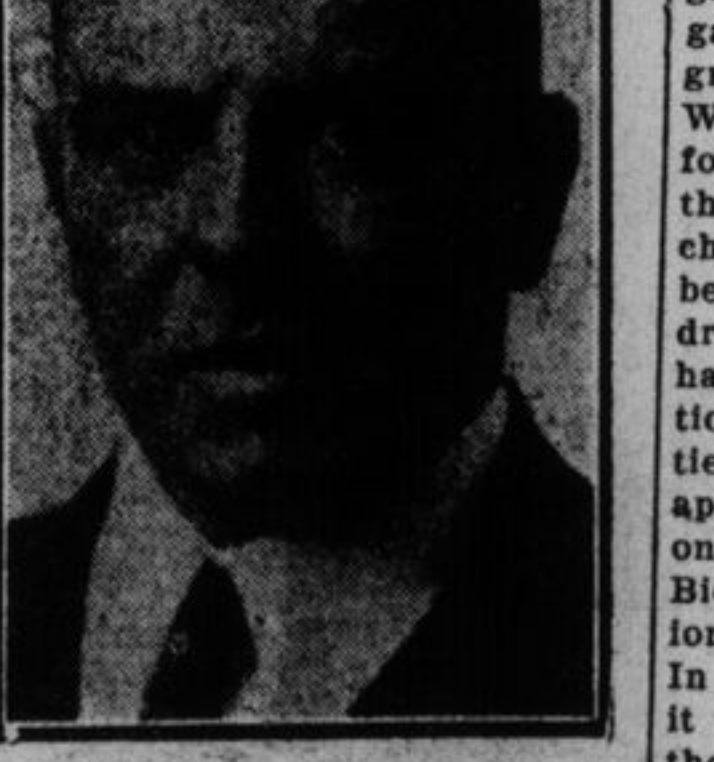

Americans and French Clash in Restaurant

Cherbourg, June 3.—The American consul here has expressed his regrets officially to the local authorities for an incident in a cafe Thursday night between American and French naval officers.

It appeared that while two French naval lieutenants dressed in civilian clothes were seated at a table in the cafe three American lieutenants from the transport Trinity, here from Gibraltar with fuel for the American naval division in passing by the French officers' table knocked over the Frenchmen's glasses. In the scuffle that ensued blows were exchanged and there was a lively mix-up.

The police intervened, inquiring into the circumstances of the incident, but made no arrests.

CHURCH UNION THE THEME

Of Greetings to the Methodist Conference From Other Denominations—Rev. Joseph Pinel Appointed Secretary.

The reception of local delegations representing the city conference and the Anglican, Baptist, Congregational and Presbyterian bodies of Kingston, all welcoming the delegates, featured Friday afternoon's session of the Montreal Methodist conference. The deputations arrived at 4 o'clock, and were introduced to the conference by Rev. W. T. G. Brown, Ottawa, a former pastor of Sydenham street church.

Ald. C. C. Nash conveyed to the conference the civic welcome on behalf of Mayor Corbett, who was unable to be present. He expressed the hope that it would not be ten years again before the conference revisits Kingston.

The Anglican delegation was composed of His Lordship, Rev. E. J. Bidwell, Bishop of Ontario, Rev. G. L. Starr, Dean of Ontario, and Francis King, K.C., secretary of the laymen of the diocese. Bishop Bidwell, who spoke on behalf of the Diocese of Ontario, the Anglican churches of Kingston, and the laity of the diocese, stated that he brought the greetings of these bodies to the delegates. He stated that he was a graduate of the same college as John Wesley, and he briefly reviewed the founding of the Methodist church by this great leader. Referring to church union, he stated that he had been on the committee which had drawn up the Lambeth appeal, which had gone to all the Christian delegations. "Although there are difficulties in it, throughout the world, the appeal has created a new atmosphere on this question," declared Bishop Bidwell. "There was now a new vision of the great church to contain all. In conclusion His Lordship said that it was his belief that the union was the will of God for His church on this earth. The church must stand as eternal sources of spiritual inspiration."

Outside Looking In.

Rev. J. S. LaPlair, of the First Baptist church, welcomed the delegates on behalf of their Baptist friends. On the question of the union of the churches, the Presbyterian, Congregational and Methodist, the Baptists were on the outside, but looking in and interested in anything that will unite the church of God. The churches must stand together for every good work for the uplift of mankind.

On behalf of the Congregationalists, Rev. A. S. Duncan, of Bethel church, spoke briefly. Rev. Malcolm MacGillivray, D.D., and Rev. Dr. R. J. Wilson representing the Presbyterian congregations of the city, Dr. MacGillivray in his introductory remarks, congratulated the president on his elevation to the chair of the president. He looked upon the gathering as fellow Christian workers, with the common mission of promoting the higher life of Canada. He stated that he was looking forward to union for which he had worked for years. He wished that undue emphasis on non-essentials be taken away, and hoped for the early realization of the movement.

Dr. MacGillivray pointed out that the three unions that have taken place in Canada had all taken time to come about, and in no case was the decision of the gatherings unanimous. "It may pay to wait," stated Dr. MacGillivray.

Claims Actor Obtained Rights to Property Through Misrepresentation.

New York, June 3.—Court proceedings were begun yesterday to force William Faversham, the actor, to return to Mrs. Julie Opp, mother of his late wife, Julie Opp Faversham, rights to property which Mrs. Opp claims Mr. and Mrs. Faversham obtained through misrepresentation.

The petition by Mrs. Opp, seeking the setting aside of a transfer of real estate made by her alleges that besides obtaining the property by misrepresentation, Faversham obtained from her large sums of money which he never repaid.

The real estate in question, Mrs. Opp alleges, was left her by her husband, John Opp, who died in 1898. Later, she charges, Faversham told her his wife was in need of funds with which to meet obligations, and asked that Mrs. Opp sign papers for a loan to be secured on this property.

These papers, Mrs. Opp claims, were afterward discovered to be quite claim deeds, turning the property over to "Peter S. O'Hara," whom she characterized as a "dummy." The consideration was \$24,000, but neither she nor anyone representing the estate of her husband has received any of this sum, she says.

She charges that Mrs. Faversham, her daughter, acting as remainderman, also had signed the deed granting the property to "Peter S. O'Hara," and that she had relied on the stories given her by her daughter and son-in-law.

Mrs. Opp now declares herself to be without means of support by reason of her "scant business experience" and Mr. Faversham's "knowledge of worldly affairs."

His Majesty's Birthday Honors Announced—Now Rt. Hon. Mackenzie King.

London, June 3.—Sir Robert Hudson Borwick, Sir Joseph Robinson, Sir William Vestey, Sir Samuel Waring and Sir Archibald Williamson are named as peers in the king's birthday list. Peers were given for services during the war.

The list includes fifteen new baronets, among them Lord Northcliffe's brother, Hildebrand Harcourt, and other noted provincial magnates and public benefactors. Forty-two commoners become knights, among them Henry Fielding Dickens, son of the famous novelist, and William Mills, inventor of hand grenades.

With William Lyon MacKenzie King, premier of Canada, in the list of privy councillors, is Col. Leopold C. M. S. Amery, parliamentary secretary to the admiralty.

QUEEN'S DRAWS TWO ATHLETES

Batstone And Munro, Noted Toronto Rugby And Hockey Players, Coming.

Toronto, June 3.—Harry Batstone and Duncan Munro, two of Toronto's well-known athletes, will enter Queen's University this fall. Batstone is considered one of the brainiest rugby players that has been produced in Toronto, and last year was captain of the Argonauts when they won the Canadian championship. In addition, he is a star baseball player, and also a member of the Aura Lee senior T.H.L. championship hockey team. Munro is one of the foremost amateur hockey players in the city, and was a host of strength to the Granites, Ontario hockey champions.

The girl, seeing what was the matter, ran to the track and crossing the rails, threw herself against the unwary child and both stumbled over the bank to the other side.

When the train had passed Marjorie led the child back to her mother.
