

will let it be churned without any greater heat than it would experience when standing eight or ten feet from the kitchen fire, and the butter will be as fine as can be made. The only inconvenience which attends this mode of making winter butter, is that it takes more time to churn it, than in warm weather. It is also a fact, that the butter will not generally have so yellow a complexion, as is common in the summer and fall. But in point of flavor, where the cows are fed upon sweet hay and provender it cannot be surpassed. This mode of making butter is well known in some parts of our country, and is as usual as making in October.

PROVINCIAL PARLIAMENT OF UPPER CANADA.

LEGISLATIVE COUNCIL, Friday, Feb. 6.

This day, at half past three o'clock, the Honorable the Legislative Council went up to the Government House with the following Address:

To His Honor SAMUEL SMITH, Esquire, Administrator of the Government of the Province of Upper Canada, &c. &c.

May it please your Honor,

We, His Majesty's dutiful and Loyal Subjects, the Legislative Council of Upper Canada, in Provincial Parliament assembled, beg leave to present to your Honor, our thanks for your Speech at the opening of this Session of the Legislature.

It is with the deepest concern, we have received your Honor's communication respecting His Majesty's Health.

Whilst lamenting the fate of a beloved King, your Honor has called our attention to the most afflicting event, the death of Her Royal Highness the Princess Charlotte Augusta, under circumstances of peculiar interest, whereby the hope of the nation hath been disappointed, and every heart filled with grief and sadness! Fully sensible that the blessings derived from the illustrious Princess, which was fondly hoped that amiable Princess, it was to continue, have not been limited to the British Isles, but extended to the remotest bounds of the Empire, and particularly to this favored Colony, whose sorrow is unfeigned and universal.

It is with peculiar satisfaction we learn from your Honor that His Royal Highness the Prince Regent has been graciously pleased to take into consideration, the loss of individuals by the invasion of the Enemy during the late war; and we will co-operate in any measure that will tend to carry into effect the gracious intention of His Royal Highness.

We will take into our serious consideration the report of the Commissioners appointed to meet the Commissioners of Lower Canada, relative to the Provisional agreement respecting the Revenue arising from Imports from Lower Canada, when the same shall be laid before us.

We entertain the hope, that great benefit will result to this Province from the accession of an industrious and Loyal Population from the United Kingdom under the continuance of His Majesty's Government.

We are not insensible to the want of suitable accommodation, for His Majesty's Representative, the Public Officers, and the Legislative and Judicial authorities, at this Seat of Government, and will attentively consider the propriety of adopting means to render that accommodation more suitable.

We will consider carefully the laws that are expired or about to expire, and afford our aid to revive and continue such as may appear to us to be necessary to the welfare of the Province, ever ready most thankfully to avail ourselves of your hearty concurrence in promoting so desirable an object.

To which His Honor was pleased to reply:—

Hon. Gentlemen, Accept my thanks for this Address, and the assurance that you will consider the several subjects submitted from the Chair.

Mr. Frazer moved, that the Petition of sundry Freeholders of the Midland District, be now read, which was agreed to and the Petition read.

To His Honor SAMUEL SMITH, Esquire, Administrator of the Government of the Province of Upper Canada, &c. &c.

May it please your Honor, WE His Majesty's most dutiful and Loyal Subjects, the Commons of Upper Canada, in Provincial Parliament assembled, beg leave to offer to your Honor, our sincere congratulations upon your accession to the Government of this Province, and to return our humble thanks for your gracious Speech from the Throne.

It fills us with the deepest sorrow, that besides informing us of the continuance of His Majesty's lamented indisposition, which we hear with undiminished concern, it has been the painful talk of your Honor, to communicate an event so afflicting, as the death of Her Royal Highness the Princess Charlotte Augusta, in circumstances peculiarly interesting. Having ever equally participated in this remote Colony, with the most favored

part of the British Empire, in the blessings derived from the illustrious House, which we fondly hoped would in the Descendants of that amiable Princess, have transmitted its virtues and its glory to the latest posterity; we seize this first opportunity of testifying in the name of that portion of His Majesty's Subjects whom we represent, their sincere sympathy in the deep distress which on this melancholy event, has overspread every part of His Dominions.

Your Honor's communication to us, of the intention of His R. Highness the Prince Regent to apply the proceeds of the Estates, vested in His Majesty, under the provisions of the Statute, to declare certain persons therein described Aliens, to compensate the loss of individuals by the invasion of the enemy, affords us a strong and gratifying proof of the gracious consideration of his Royal Highness for those of His Majesty's faithful subjects who suffered in the late contest, and we shall feel it a pleasant duty to concur in any Legislative provision, that may be necessary to give to such benevolent intentions their fullest effect.

The Report of the Commissioners appointed on the part of this Province, to meet those of Lower Canada, for the purpose of forming a Provisional Agreement relative to the Revenue, shall receive our consideration. We shall carefully examine the Accounts of last year's Expenditure, and give the Estimate for the present year, due consideration.

We heartily concur with Your Honor in the expectation that great benefit will result to this Colony, from the accession of an industrious and Loyal Population from the United Kingdom, and learn with delight the countenance given by His Majesty's Government to the Migration of a description of Persons in whose behalf we feel ourselves lively interested, and that take into our consideration what your Honor has recommended upon the subject.

Knowing the great measure of that have been already expended, and are now felt to be a heavy burden on the want of a remuneration for His Majesty's Representatives in the Public Office, and the Magistrate and Judicial Authorities, in the Seat of Government, we shall certainly take into consideration the expediency of replacing the same, with a view to a just appreciation of former years, and already accumulated liabilities, which we feel it our duty to do, in order to do it in a judicious and equitable manner, and we beg to assure your Honor of our entire confidence in your Honor's desire to promote all measures, that have for their object, the prosperity of the Province.

And having returned, the Speaker reported the same to the House, and that His Honor had made a reply thereto, which was read by order of the House, as follows:—

GENTLEMEN,

I thank you for the Address and the assurance of Personal Congratulation. The expression of your sorrow on the event so afflicting to us, is creditable to you as men and Subjects.

I feel assured of your concurrence as to the propriety of taking some step for the accommodation of the various branches of the Government, and I thank you for the very cordial assurance of that concurrence.

Mr. Van Koughnet gave notice, that he will, on Wednesday next, move for leave to bring in a Bill, to alter the time of holding the Court of General Quarter Sessions of the Peace for the Joins town District.

Mr. Robinson gave notice, that he will, on Thursday next, move for leave to bring in a Bill, to regulate the Duties on the Importation of Grain, Wares, and Merchandise, from the United States to this Province.

Agreeable to the Order of the Day, the Sabbath Profanation Bill was read the second time.

Mr. Cameron moved, that this House do resolve itself into a Committee of the whole, to take into consideration the Sabbath Profanation Bill, which was agreed to, and the House went into Committee.

The House resumed.

Mr. McDonnell reported progress, and had leave to sit again to-morrow.

Agreeable to the Order of the Day, Mr. Van Koughnet moved for leave to bring in a Bill, to alter and amend an Act passed in the 47th year of His Majesty's Reign, entitled, "An Act to establish Public Schools in each and every District in this Province," and to extend the provisions of the same, which was agreed to and the Bill was read.

Mr. Van Koughnet moved, that the District School Bill be read a second time to-morrow, which was ordered.

Mr. Robinson gave notice, that he will, on Saturday next, move that the House do resolve itself into a Committee, to take into consideration that part of His Honor the Administrator's Speech at the opening of the Session, as relates to the Public Buildings.
