As to the Canada Trade Act, ANNO PRIMO GUILLIAMI IV, REGIS, he will consider it merely as one of the compliments of political fencing and commercial scribble "one, two, and the third in your own bosom, as Mercutio says,—the very butcher of a silk button." Besides those who deal in transports are not very disposed to trouble themselves with balancing tables of Exports and Imports; and have too much of the romantic theory of robbing from Robin Hood down to Lord Byron's Corsair, to relish diplomatic swindling under the name of Reciprocity. He would very likely conclude by pointing out an old act which has never been repealed, anno primo Adami—entitled "omnia vincit amor."

EFFECTS OF SAVING.—In England, Wales, and Ireland, there are 480 banks for savings. The sum of money deposited in the e banks is 14,500,000*l.*; and the number of depositors is 410,000. The greater number of persons who are depositors are working men and women; they are the capitalists who, together, have accumulated a capital of above fourteen millions of money, and receive an annual interest upon that capital of about half a million. How has this great sum of money been accumulated? By savings. The man who, at the age of 21, puts only 1*s.* a week in a savings' bank, and continues to do so until he is 30, has acquired a capital of above 30*l.* If he has saved, during the same time, 2*s.* a week, he has a capital of above 60*l.*; if 3*s.* a week, he has acquired 100*l.* Thus, we see that a single man steadily lays up 5*s.* a week for nine years, at the end of that time he has capital enough to live upon without working at all, for at least three years.
