United States. ROBBERY OF POMEROY'S EXPRESS. We mentioned yesterday from the Albany Argus the arrest of P. H. Rust, of Syracuse, and Mr. Banks of Washington, on suspicion of being implicated in the robbery of Pomeroy's Express. We have since received authentic information of the circumstances which led to their arrest, and which are deemed conclusive evidence, by the most deeply interested, of its propriety and necessity.
