Run Off on a Railway.

Belleville, May 12 .- A run-off took place on the midland division of the Grand Trunk RR. yesterday, five miles west of Campbellford. The engine and ten cars left the rails. Driver Mattock had his leg broken. Fireman Taylor sustained severe internal injuries. Cause of accident unknown.

Ontario's Educational System.

TORONTO, May 11.—Lord and Lady Lansdowne were presented with an address by the public school board yesterday. In reply to the address the governor-general said : "In religious matters your system is conceived in a truly liberal spirit, in regard to the provision made for those whose scruples and convictions separate them from the main body of your citizens."

Taking a Decided Stand.

RERLIN, May 12.—The election at Strasbourg, for a member of the Reichstag, in place of Deputy Kable, deceased, is fixed for June 2nd. The protestors, acting under instructions from Paris, decline to nominate a candidate. This threatens to be the prelude to the withdrawal of all the protestors in the Reichstag, with a demonstration against the repressive measures taken in the Reichstag.

Reprisals on the Germans.

Paris, May 12.—The government has closed a velocipede factory at Marainsvillex, near Luneville, the property of a German named Schinertzer, who employed men belonging to the German imperial army. The incident is supposed to be the prelude to other reprisals against the Germans. La France denounces in Laboulaye, the French ambassador at St. Petersburg, for retaining a Prussian in his service as a chasseur.

APPLYING THE CLOTURE

Mr. Gladstone Defends Himself—The Coer-

cion Bill is Advanced Another Stage. LONDON, May 11.-Mr. Gladstone was present at a luncheon given to forty nonconformist ministers at the residence of Dr. Parker of the city temple. He made an address of one hour's length. He had no reason to charge the Parnellites with complicity in Irish crime. While prime minister he denounced them as dangerous. That was totally different from charging them with crime. In conclusion Mr. Gladstone vehemently denounced the government's attitude on the Times' charges against the Irish members, and said that the prosecution of the Times by the crown would be a horri-

ble farce. LONDON, May 11.—The house resumed consideration in committee of the Coercion bill. Peter McDonald, nationalist, moved the adoption of an amendment to the effect that the evidence of witnesses at preliminary inquiries should not be adduced against them except in case of perjury. Mr Baltour opposed the amendment; the clause was necessary to induce witnesses to give evidence. Professor James Stuart, of St. Andrew's university, declared that the clause was a most serious innovation in criminal law. T. M. Healy said the Irish party was fighting for one of the oldest principles of English jurisprudence. Hon. W. H. Smith insisted that the committee divide. Cloture was put and carried by a vote of 265 against

LONDON, May 11 .- Mr. Parnell will arrive in London to-morrow morning. His health is improved.

LONDON, May 11.—It is reported that the government, acting on information from New York, has sent the cutter Orwell to Carrigabolt, Ireland, to watch for the arrival of an American vessel with a cargo of arms and explosives.

HIS MISSION TO CANADA.

O'BRIEN'S THORNY PATH - COLD SHOULDER EVERYWHERE.

People do not Sympathise With His Attacks on the Governor-General - He Knows That the Sentiment of Ontario is Against Him-The Incident Out of new York.

MONTREAL, May 12 .- Mr. O'Brien lectured last night in Albert hall before a very large audience. Representatives from Ottawa and Kingston were present. The lecturer said he was sorry to come to this land with the cruel story of the wrongs and suffeaings of the afflicted tenantry of Luggacurran. Io whem should the people of Ireand turn, if not to their fellow-countrymen in Canada.

He had not come to appeal to the passions, but to the reason and humanity of the free and liberty-loving people of Canada. The Canadian parliament in 1879 voted £20,000 to buy bread for the starving women and children, starving in the midst of that beautiful and fertile land. Parnell said that never again would he go begging alms for the victims of landlordism. This time they did not ask for £20,000, but desired Canadians to know the use which Lord Lansdowne makes of the £20,000 he received from them, and, if it were found he had been making a bad use of it, to ask to pass their condemnation on his acts. The Canadian parliament struck at the root of the evil in Ireland when it passed the resolution in favor of Irish home rule. Even recently the parliament of Canada had endeavored to stand between the Irish ple and coercion, as they did between them and starvation long ago. Personally, he had no ill-feeling against Lord Lansdowne, but the Irish people could not lie down like whipped hounds at his feet without telling the story of their wrongs. The day that the condemation of the Canadian people is passed on the acts of Lord Lansdowne that day will have nerved the arm of the Honorable William Ewart Gladstone in his great battle for the right of suffering Ireland. It was not his intention to make any personal attack on Lord Lansdowne. He would not call up the ghostly memories, but he would tell how Lord Lansdowne was laying waste that fine estate and carrying out the work of depopulation as if the angel of death had knocked at the door of each humble cabin, and still the processes were not half served. If Lord Lansdowne or his agents were let alone there was not a man, woman or child on the estate of Luggacurran but would be banished from the houses of their fathers and either compelled to starve on the roadside or seek homes beyond

Mr. O'Brien then read extracts from The

Freeman's Journal, which described terrible eviction scenes. In the four days the work of eviction lasted on the Lansdowne estates 120 persons had been turned from their homes into the roadside. Old men and women of 80, and helpless babes only a few weeks old suffered alike, and this in the severe weather of March and in the face of a pitiless storm. These scenes were witnessed by the speaker, and he had seen Father F. Meagher and Mr. McBride take off their coats and give them to cover the shivering babies at their mother's breasts. It was because of such scenes that he looked to the people of Canada for their condemnation of Lord Lansdowne. It was Canadian money that paid the officers who carried out these cruel evictions. Lord Lansdowne had tried to explain, by interviews in the press, that these people owed a year's rent. They only owed half a year's rent, and the law said that a whole year must be owed before a tenant could be evicted. The other half year's rent was called the hanging gale. This was simply a lawyer's fiction, and had been instituted years and years ago to enable the other landlords to evict their tenants whenever they would be half a year behind the payment of their rents. The tenants of the Lansdowne estate were the most punctual and peaceful in the whole of Ireland. Not a murder had been committed in the vicinity of Luggacurran for years. The only crime which these people were accused was wishing for some reduction in the rack rent. This was a reduction of 80 per cent., which was even less than Lord Cowper and the land commission had offered on other estates, and these very reductions had been approved of by Lord Lansdowne. The estates were of two classes. The first were leaseholders, who were not as yet entitled to go into the courts, and the other class were the judicial tenants, who have already had their rents fixed by law. The leaseholders asked for a reduction of 30 cent. If these tenants were free to go into the land courts, as the tory government propose to allow them, they would, according to the decision of the land commission, get

a reduction of 40, 50 or 70 per cent. A resolution was passed condemning Lord Lansdowne's actions. The meeting was most orderly, and no hostile demonstrations were offered at any time through the day or

evening. On the stage were suspended an Irish flag, portraits of Parnell and Justin Mc-Carthy, and large placards bearing the mottoes, "Home Rule for Ireland in Sight," "Dublin Castle Doomed," "Success to the Plan of Campaign," "Ireland's Patriotic Prelates, Walsh, Croke and Nulty." Mr. H. J. Cloren, president of the land league, introduced the speaker, and read a despatch from Toronto stating that Mayor Howland intended to call a public meeting to decide on taking steps to prevent Mr. O' Brien speaking there. The reading of the despatch was greeted with loud hisses and cries of "To hell with Toronto," Mr. Cloran said that was not British fair play. (Cries of "Let him fight it out.") Mr. O'Brien had sent a reply offering to meet Mayor Howland at any meeting and state his reasons (for coming to Canada, (Applause.) Mr. Cloran then attacked the press of the country, which he said had maliciously misrepresented the object of Q'Brien's visit. Mr. O'Brien did not give a rap for their opinion, but they should do justice for the sake of the poor innocent men and children on the estate of a gentleman named Lansdowne. (Hisses.) Their guest did not come to stir up religious prejudices, like Dr. Kane and Mr. Hill Smith -(loud hisses) -- who had been allowed to go through the country with their tirades by the very people who were now objecting to O'Brien's visit. The field was clear for O'Brien here. It would be clear all over the country or the Irish people would know the reason why. (Loud applause.)

Statement of Mr. Kilbride,

NEW YORK, May 11 .- A tall broadshouldered man, with pointed red beard, fine complexion and dignified bearing, is Mr. Kilbride, the first tenant farmer evicted from Lord Lansdowne's estate at Luggacurran. He missed the train on which Mr.

O'Brien left for Montreal. He said : "I had a farm of 540 acres in Queen's county, near Luggacurran. Of this 300 acres were poor, being rushy. It was all grass land and I raised young cattle, selling them when they were two years and a half old. For this farm I had to pay every year £700 11s. The government valuation was only £424. I have not made the rent on the place since 1879, and there was no way of helping myself. I had seven families living in cottages and in summer had twenty men working. The result of all this hard labor, added to my own hard work and my capital, did not produce enough to pay the rent demand-

ed by Lord Lansdowne. "All appeals to Lord Lansdowne were met with a reply that he would do nothing. Finally we found that the rent could be paid no longer, and we adopted the national plan of campaign by placing our money in the hands of national representatives. On March 22nd of this year evictions began. The police, armed with rifles or batons, had been massing for two days around our neighborhood. I was the first to be evicted. Three hundred armed policemen, with a special force of forty, supplied by the landlords' association, surrounded my place.

"There was a long avenue of trees leading to my residence and I had them all felled, so that they lay across the road and made it impassable for the large force of policemen. The police carried pontoon bridges and corrugated iron ladders, so that they crossed the fields and streams, reaching my house without having to clear away the huge

"When the sheriff reached the house I | C was in a small upper room with three B friends. I had chained the iron farm gates across the door and braced this barrier by a section of a big tree which ran across to the other wall. The sheriff's men could not force the door open, so they cut away at it with hatchets for half an hour. The iron gates bothered them. I stuck out a little bottle of castor oil. The men were in a great fright and thought it was dynamite. Then they got a ladder and cut a hole through the roof in order to reach me. I lit my pipe and left peaceably.

"On the next day they evicted all the poor families living on my holdings. I was the last man put out of each house. At the end of the day the sheriff said to me, 'Mr. Kilbride, you're the most thoroughly evicted man in Ireland, for I've evicted you at least a dozen times to-day.' There is my dear old farm empty. Not a man in Ireland would go to live on it now. Will I go back to it? Please God, I will. Our cause is unconquerable."

Mr. Kilbride said that the English passengers on the Umbria did all in their power to annoy Mr. O'Brien. "After the scene which these Englishmen made when Mr. O'Brien left the vessel," he said, "every American on board pronounced it an out-

The Row on the Umbria.

When asked about the scene that took place when the reception committee came to take him off the steamer Mr. O'Brien was inclined to be charitable to those on board who made the demonstration against him.

"I received every courtesy during the voyage," said Mr. O'Brien, "and it was only at the last that any ill-feeling was shown against me. There were a few young English tories on board, and a Mr. John Fox, a loyalist town councillor of Cork. Of course Mr. Fox was very much opposed to me, and no doubt there had been a good deal of smoking room gossip about my actions. I was below when the trouble first began, and thought the noise was due to an entertainment that was going on in the saloon. There was, I hear, some trouble between Mr. Fox and Bishop Ireland, but I was not present when it occurred. I think some of the ill-feeling was caused by the fact that I had delayed the vessel at Queenstown for over an hour, owing to my having to receive deputations there. This lost hour some of those on board felt was the cause of our getting into the fog, which prevented our landing in New York on Saturday. Then when they saw that I, the cause of this trouble, was to land before them, they naturally were annoyed. I should have remained on board to share their fate, but was put out by some very blackguardly expressions that were used. Captain McMickan could have prevented any trouble had he chosen. He seemed to interpose in every possible way to prevent Bishop Ireland, Mr. Kilbride, and myself from landing. The breaking of the hawser was purely acciden-

The captain had said that none should leave the ship until the medical officer had inspected her. Dr. Smith was on board the tug, but could not make himself heard, and when he was recognized the tug had steamed off. Thus it was that Mr. Kilbride, of Luggacurran, was not with Mr. O'Brien on the train when it reached Montreal.

The Feeling is Against Him.

MONTREAL, May 12. - When asked if he was aware that there was a strong opposition to his mission on the part of many people in Canada, Mr. O'Brien replied : "Yes, there will be people who differ with us until the end of the chapter. I do not mean to force my opinion on any one. I simply desire the people to hear my statements and give them a fair consideration. So far as I understand, the feeling of the population in Ontario and specially in Toronto is against me, but I believe that in fighting this battle against Lord Lansdowne we are doing a work that is quite as beneficial, and calculated to do as much good to the Orangemen and the Protestants in Ireland as to any part of the Irish population. I do not, therefore, anticipate any very strong opposition as the Canadian people have shown their sentiments regarding Ireland so often."

The Mission is Unpopular.

LONDON, May 10 .- The Daily Telegraph, commenting on Mr. O'Brien's trip, says: "If the fortunes of Mr. O'Brien's tour are correctly foreshadowed by the incidents of his landing we may expect lively proceedings. The public intelligence of Canada ought to rebel against Mr. O'Brien's independent propaganda, and if it does it is quite possible the revolt may rise to indignant heights and lead to riotous collisions."

London Truth does not think it likely that Cambridge will send an eight-oared crew to America this year. It thinks the eight that beat Oxford will be available, and suggests that the race in the United States be a four instead of an eight-oared

Mr. Richard K. Fox, of New York, has sent the Clipper a forfeit of \$1,000 on behalf of Jake Kilrain, of Baltimore, to fight John L. Sullivan for the championship of America for \$5,000 a side and the Police Gazette diamond belt, according to the London prize ring rules.

In England this year provision has been made for 245 days' racing, and nearly \$2, 000,000 are to be run for. Some 2,300 horses will compete for this enormous sum. Last year 2,072 animals ran under Jockey Club rules, of which 877 were two-years-olds and 602 four years and upward. These proportions represent about the average of many years.

EPIDEMIC IN GLENGARRY.

An Infectious Lung Trouble Carrying Off Many of the Inhabitants.

ALEXANDRIA, May 11.-A remarkable epidemic prevails in Lancaster township. It is the nature of an infectious lung trouble, and after an attack its victim rarely survives a week. Within the last few months about twenty-five deaths have occurred in Glen Nevis Catholic parish. Within the last ten days three members of one family have been carried off. First the hired man died after short illness, then the father, and on the evening of the funeral day of the latter his son, who had come from Montreal to attend the last ceremonies, was also suddenly attacked and soon expired. The disease is said to have its origin in the foul stenches which arise from the putrid decaying matter deposited annually along the banks of the River Beaudette.
