Country Calls.

This morning Mr. Lyman Lyon, of Stratton, brought into the sanitarium a fine lot of new potatoes, large and plump. He got far ahead of the beetles as well as his neighbors, and can take the lead in the early potato ranks.

It was also reported to-day how Mr. Alex. Young, of Pittsburg, treated the potato bugs in his fields. He scouted heliothis, salpistres, tobacco and other destroyers, and went at the bugs hoe in hand. In two hours and a half he picked 1237 beetles off the plants, and having killed these, for a while he will sail along with a smiling potato patch.

Several farmers have reported a severe frost last night. A little injury was done in low lands.

Farmers to-day report barley as a fair crop, though less was sown than last year; peas good; oats poor; spring wheat below the average; hay very light on clay lands; plums blighted; apples promising well; potatoes covered with beetles, and corns attacked by insects. The crops promise only an average generally.

Mr. S. S. Baker, of the Lake Shore Milk Dairy, has brought in fine heads of timothy, (10 inches long), plucked from a field of twenty-four acres on his farm. He has forty acres of meadow that will cut two tons to the acre, an exception to meadows generally this year. The patrons of the dairy may expect good milk next year.

BOILER.—A. V. Housman, tinner in Molson's Bank, Toronto, has suddenly left under a cloud. The teller in various banks suspected him of fraud in counting packages of money sent from one bank to another, and complaining of shortages when they were made up.
