A TWO HOURS FIGHT. A Lively Time Reported From San Juan, Porto Rico.

CAPE SAN JUAN, Aug. 9.—A two hours' fight took place before daybreak yesterday.

WITH BUT SHORT DELAY

The Terms Will Be Ratified Very Soon.

SECRETARY DAY'S VIEWS.

THE DATE OF EVACUATION NOT MENTIONED.

A Commission To Be At Once Appointed to Meet in Paris—Who the Commissioners Will Probably Be—Ambassador Cambon Waiting for Permission from Madrid to Sign the Protocol—Day Believes Permission Will Be Granted.

WASHINGTON, Aug. 11.—Secretary of state Day, speaking yesterday of Spain's reply accepting the terms proposed by the United States as a basis for peace negotiations, said: "We have agreed upon a protocol embodying the proposed terms of the negotiation of a treaty of peace, including the evacuation of Cuba and Porto Rico, and it is expected this protocol will be executed, Spain's reply having been construed by the administration to be a definite acceptance of the terms proposed by the president."

Secretary Day expects ambassador Cambon to receive full authority from Madrid to-day to sign the protocol, and in that event it will be signed without delay, and hostilities between the United States and Spain will cease as soon as the commanders of the two governments in the West Indies and the Philippines can be notified.

The protocol as drawn up is an elaboration of the terms published in these despatches yesterday. It does not fix the date of the evacuation of Cuba and Porto Rico by the Spanish troops. This is a detail which is to be left to be arranged by the military commanders of United States and Spain.

Brantford real estate agents claim they cannot supply the demand for houses. The homestead entries at the dominion land agencies in the west numbered five hundred last month.

Mr. Curzon's appointment as viceroy of India is officially announced. It is said he will be raised to the peerage. Mrs. Amy Blizard, Washdenoak Lake, P.E.I., will, if she lives, celebrate her 100th birthday on August 16th.

Arrangements have been made by Norton & Son for a direct steamship service from New York to New Zealand. Joseph G. Small, Smallgrove, who fell a distance of twenty-eight feet in his barn Saturday last, died of his injuries yesterday.

The free library at Brantford was burglarized on Saturday night, the robbers getting ninety-three cents and leaving \$6. Intense heat prevails in British Columbia. At Kamloops the temperature has reached 100° in the shade every day this week.

It is said a deal has been closed whereby the Massey-Harris company, Toronto, will operate a big corundum mine in North Hastings. Brantford proposes that the Walter L. Main circus should winter in that city, and suggests the vacant Grand Trunk shops be used for the purpose.

Lucy Millidge, a young daughter of Rev. Mr. Millidge, rector at Oak Bay, N.B., was drowned while bathing with several other ladies in the bay. Police magistrate Parke, of London, ordered that 3,500 copies of an alleged medical work, seized by the police as obscene literature, should be burned.

A full exhibit of grains, grasses, etc., is being shipped by the Manitoba department of agriculture to W. D. Scott, Toronto, and will be put on exhibition at the industrial fair. The North German Lloyd's steamship Saale, Capt. Blanke, from New York for Southampton and Bremen, passed the Lizard yesterday. She had lost one blade of her propeller.

INDIA'S NEW VICEROY.

Curzon's a Strikingly Brilliant Career—A Breakdown in Health.

LONDON, Aug. 11.—Mr. Curzon, the new viceroy to India, will probably start for Calcutta in November. The appointment excites quite unusual interest. All the morning papers publish, in addition to editorial, a special article reviewing his strikingly brilliant career, wishing him success and generally expressing approval of the appointment, though some doubts are suggested on the score of his comparative youth as a statesman and the fact that he is supposed to advocate a "forward policy" regarding the northwestern frontier of India.

The Daily Chronicle says: Mr. Curzon risks his whole career on this shining peak. Unless he makes a great success he will make a very great failure. Many American ladies have graced the society of the old country as the wives of prominent men, but to none of them has it been given to play such a part in the British empire as Mrs. Curzon will enjoy.

MUST DIVULGE REASONS. Wheelmen Want Tuff Reinstated—Conference of G.T.R. Officials. MONTREAL, Aug. 11.—E. A. Walton, chairman of the dominion racing board of the C.W.A., at present in the city, was called on last night by a deputation of the leading wheelmen who requested him to take in consideration the reinstatement of Walter Tuff, who was transferred to the professional class not long ago.

Joseph Price, vice president of the G.T.R., is expected in the city to-night from New York, where he landed on his arrival from England. Sir Charles Rivers Wilson, the president, and Mr. Hays, general manager, will be in the city this afternoon for the purpose of meeting Mr. Price. They will then arrange their plans for inspection of the system which it is their intention to proceed with.

It transpires that Simpson was feigning insanity all along. The police are now looking for him as there several serious charges against him. It has been definitely decided that Duggan will not sail the Seawanbaka cup defender Dominion on Saturday. Commodore Jarvis, Toronto, will take his place for that day and Duggan will rest and be ready for the race on Monday.

THE ONTARIO LEGISLATURE. Continuation Of the Debate On the Address. TORONTO, Aug. 10.—The chief feature of the debate in the legislature to-day was the resolutions which the premier proposed in reference to Mr. Whitney's contention that the liquor influence was manipulated in support of the government candidates at the last election.

Mr. Graham, the new member for Brockville, in a clever speech, read a strictly confidential circular sent by the secretary of the license holders' protective association to the local secretary of Dundas county. Mr. Whitney's constituents, instructing them that as the present member voted in favor of the trade and against municipal control it is unnecessary to ask him the questions which are to be put to other candidates whose views are unknown, as it would be unwise to embarrass him in his campaign, and they knew his friendly attitude to the trade. The principle is also laid down in the circular that "common gratitude as well as sound policy dictate that we should stand by those that stand by us."
